RESOLUTION NO. 2011 - 127

A RESOLUTION AUTHORIZING CLAYTON COUNTY TO EXECUTE A 2011 SELF-SURVEY AND TITLE VI ASSURANCES REQUIRED BY THE GEORGIA DEPARTMENT OF TRANSPORTATION REGARDING COMPLIANCE WITH TITLE VI OF THE CIVIL RIGHTS ACT OF 1964; TO AUTHORIZE THE DIRECTOR OF THE TRANSPORTATION AND DEVELOPMENT DEPARTMENT AND THE CHAIRMAN TO PERFORM ALL OTHER ACTS NECESSARY TO ACCOMPLISH THE INTENT OF THE RESOLUTION; TO PROVIDE AN EFFECTIVE DATE OF THIS RESOLUTION; AND FOR OTHER PURPOSES.

WHEREAS, pursuant to 23 CFR Part 200, Title VI of the Civil Rights Act of 1964, the Civil Rights Restoration Act of 1987 (P.L. 100.259), and all related regulations and directives, Georgia Department of Transportation (“GDOT”) assures that no person shall on the grounds of race, color, or national origin be excluded from participation in, be denied the benefits of, or be otherwise subjected to discrimination under any of its programs or activities whether or not those programs and activities are federally funded; and

WHEREAS, GDOT’s sub-recipients, including Clayton County, are required to include Title VI language in all written agreements and must monitor such agreements for compliance; and

WHEREAS, all of GDOT’s sub-recipients must have a signed Title VI Self-Survey, as well as Assurances, on file as conditions to receiving pass through federal financial assistance from GDOT; and

WHEREAS, the Board of Commissioners deems it in the best interest of Clayton County, and the County will best be served by authorizing the Director of the Transportation and Development Department and the Chairman to execute a Title VI Self-Survey and Assurances, respectively, for the purposes above.

NOW THEREFORE, BE IT RESOLVED BY THE BOARD OF COMMISSIONERS  
OF CLAYTON COUNTY, GEORGIA AND IT IS HEREBY RESOLVED

Section 1. The Clayton County Board of Commissioners authorizes the County to execute a 2011 Self-Survey and Title VI Assurances required by the Georgia Department of Transportation regarding compliance by the County with Title VI of the Civil Rights Act of 1964. The Board of Commissioners hereby authorizes the Director of the Transportation and Development Department to execute the 2011 Self-Survey and the Chairman to execute the Assurances, and perform all acts necessary to accomplish the intent of this Resolution.


Section 2. This Resolution shall be effective on the date of its approval by the Board of Commissioners.




