RESOLUTION NO. 2011 - 139

A RESOLUTION AUTHORIZING CLAYTON COUNTY, ON BEHALF OF THE CLAYTON COUNTY PARKS AND RECREATION DEPARTMENT, TO GRANT A SPECIAL FACILITY USE REQUEST FOR ROTARY CLUB OF CLAYTON COUNTY, INC. TO SPONSOR AND HOST AN ALL-NIGHT SLEEP-OVER FOR INTERNATIONAL COLLEGE STUDENTS AT THE CLAYTON COUNTY INTERNATIONAL PARK; TO AUTHORIZE THE CHAIRMAN TO PERFORM ALL ACTS NECESSARY TO ACCOMPLISH THE INTENT OF THIS RESOLUTION; TO PROVIDE AN EFFECTIVE DATE OF THIS RESOLUTION; AND FOR OTHER PURPOSES.

WHEREAS, the Clayton County Parks and Recreation Department received a Special Facility Use Request from Rotary Club of Clayton County, Inc. (the "Request") for use of the VIP Building at the Clayton County International Park (the "Park") for the purpose of having an all-night sleep-over for international college students, for team building activities and swimming; and

WHEREAS, Clayton County has traditionally supported the work of various non-profit organizations, governmental agencies, and professional service providers located and conducting business in Clayton County for the benefit of the County's citizens; and

WHEREAS, the Park space will be utilized between the hours of 6:00 p.m. on September 17, 2011 and culminating at 10:00 a.m. on September 18, 2011; and

WHEREAS, Rotary Club of Clayton County, Inc. will provide over-night chaperones and will pay for the services of eight County lifeguards and one coordinator for safety and security purposes during the event, however swimming will be allowed only from 1:00 p.m. to 4:00 p.m. on September 17th; and

WHEREAS, the Board of Commissioners deems it in the best interest of the County, and the County will best be served by granting the Request of the Park space for the stated purpose.

NOW THEREFORE, BE IT RESOLVED BY THE BOARD OF COMMISSIONERS
OF CLAYTON COUNTY AND IT IS HEREBY RESOLVED

Section 1. The Board of Commissioners hereby authorizes Clayton County, on behalf of the Clayton County Parks and Recreation Department, to grant Rotary Club of Clayton County, Inc. a Special Facility Use Request to have an all-night sleep-over for international college students at the VIP Building at Clayton County International Park, and also authorizes the Chairman and the Director of the County's Parks and Recreation Department to execute any documents necessary, and otherwise perform all acts necessary to accomplish the intent of this Resolution.


Section 2. The Board of Commissioners authorizes the Chairman to perform any acts necessary to accomplish the intent of this Resolution.
