RESOLUTION NO. 2011 - 170

A RESOLUTION AUTHORIZING THE ACCEPTANCE OF TWO CONDEMNED VEHICLES TO BE ASSIGNED TO THE CLAYTON COUNTY POLICE DEPARTMENT FLEET IN A MANNER AS WILL BE IN THE BEST INTEREST OF THE COUNTY; TO PROVIDE AN EFFECTIVE DATE OF THIS RESOLUTION; AND FOR OTHER PURPOSES.

WHEREAS, the Clayton County Police Drug Task Force seized a 2005 Pontiac Grand Prix, VIN 2G2WP522X51131812 and a 2006 Chevrolet Silverado C-150, VIN 1GCEC14X06Z128236 during a drug investigation; and

WHEREAS, the Clayton County Police Drug Task Force did petition the District Attorney for forfeiture of said vehicles to the County; and

WHEREAS, the Superior Court of Clayton has forfeited ownership and title of said vehicles to the County under court order in case number 2010-CV-04369-9, 2010-CV-02363-8; and

WHEREAS, the Director of Fleet Maintenance has determined said vehicles is suitable for service as a county vehicle; and

WHEREAS, the Board of Commissioners deems it in the best interest of Clayton County and the County will best be served by accepting said vehicles and assigning it to the Clayton County Police Drug Task Force to enhance law enforcement in accordance with applicable State Statutes.

NOW THEREFORE, BE IT RESOLVED BY THE BOARD OF COMMISSIONERS

OF CLAYTON COUNTY, GEORGIA AND IT IS HEREBY RESOLVED

Section 1. The Board of Commissioners hereby authorizes Clayton County, to accept title to a 2005 Pontiac Grand Prix, VIN 2G2WP522X51131812; and a 2006 Chevrolet Silverado C-150 Truck, VIN 1GCEC14X06Z128236; to assign said vehicle to the Clayton County Police Drug

Task Force vehicle fleet for the purpose of enhancing law enforcement in accordance with Clayton County Superior Court order case numbers 2010-CV-04369-9 and 2010-CV-02363-8. The Directors of Central Services and Fleet Maintenance are authorized to perform all acts necessary to effect this resolution.

Section 2. This Resolution shall be effective on the date of its approval by the Board of Commissioners.


