RESOLUTION 2011 – 203

A RESOLUTION AUTHORIZING CLAYTON COUNTY TO ENTER INTO A STATEWIDE CONTRACT WITH THE GEORGIA DEPARTMENT OF ADMINISTRATIVE SERVICES FOR THE PURCHASE OF IBM DIGITAL IMAGE STORAGE HARDWARE; TO AUTHORIZE THE CHAIRMAN TO EXECUTE THE CONTRACT AND OTHERWISE TO PERFORM ALL OTHER ACTS NECESSARY TO ACCOMPLISH THE INTENT OF THE RESOLUTION; TO AUTHORIZE THE FINANCE DIRECTOR TO PROVIDE FOR IN THE BUDGET AN APPROPRIATE REVENUE SOURCE AND EXPENSE, ALL AS MAY BE REQUIRED UNDER THE TERMS OF THE CONTRACT; TO PROVIDE AN EFFECTIVE DATE OF THIS RESOLUTION; AND FOR OTHER PURPOSES.

WHEREAS, Clayton County's current digital image archival storage system houses public safety images, reports, files, court records and tax deed information; and

WHEREAS, the County's current storage system is obsolete and will be unsupported and no longer repairable after December 2012; and

WHEREAS, it has been determined that it will take approximately twelve (12) to fourteen (14) months to migrate the data from the current system to a new solution; and

WHEREAS, the County recognizes the need to purchase hardware for a new storage system that will allow for limitless digital image archiving and storage expansion and provides for disaster recovery; and

WHEREAS, funds are available in the 2008 SPLOST for the purchase of said hardware; and

WHEREAS, the County also recognizes the benefits of using a Statewide Contract with IBM to purchase the hardware needed to support a new storage system; and

WHEREAS, the Board of Commissioners deems it in the best interests of Clayton County and the County will be best served by entering into a Statewide Contract for the stated purpose.

NOW THEREFORE, BE IT RESOLVED BY THE BOARD OF COMMISSIONERS
OF CLAYTON COUNTY, GEORGIA, AND IT IS HEREBY RESOLVED.

Section 1. The Board of Commissioners hereby authorizes the County to enter into a Statewide Contract with the Georgia Department of Administrative Services to purchase IBM digital image storage hardware. The Contract is attached as "Exhibit A". The Board of Commissioners hereby authorizes the Chairman to execute the Contract and to perform all other acts necessary to accomplish the intent of this Resolution. Further, the Board of Commissioners hereby authorizes the Director of Finance to provide for an appropriate revenue source and expense, all as may be required under the terms of the Contract. The Contract shall be in substantially the form attached hereto.

Section 2. This Resolution shall be effective on the date of its approval by the Board of Commissioners.




