RESOLUTION NO. 2010 - 44

A RESOLUTION AUTHORIZING CLAYTON COUNTY TO ENTER INTO A LICENSE AGREEMENT WITH LEON TUCKER PROVIDING FOR THE TERMS AND CONDITIONS UNDER WHICH A MOTHER'S DAY WEEKEND CONCERT ENTITLED "MOTHER, THIS IS FOR YOU" WILL BE CONDUCTED AT THE CLAYTON COUNTY INTERNATIONAL PARK; TO AUTHORIZE THE CHAIRMAN TO EXECUTE THE AGREEMENT, AND OTHERWISE PERFORM ALL OTHER ACTS NECESSARY TO ACCOMPLISH THE INTENT OF THIS RESOLUTION; TO PROVIDE AN EFFECTIVE DATE OF THIS RESOLUTION; AND FOR OTHER PURPOSES.

WHEREAS, Leon Tucker (the "Promoter") wishes to utilize the Clayton County International Park (the "Location") to provide a Mother's Day weekend concert where the County is solely responsible for providing personnel for facility maintenance; and

WHEREAS, the Promoter wishes to utilize the Location, located in Jonesboro, Georgia on May 8, 2010 from approximately 8:00 A.M. until 11:00 P.M., with the purposes of assisting in the development of a branding image for the International Park Amphitheater as a destination for concerts, and providing citizens a place to be entertained in a family-friendly atmosphere; and

WHEREAS, tickets for admission to the concert will be sold to the public for a purchase price of \$50.00 per person; and

WHEREAS, the Promoter is qualified to organize and facilitate projects that promote community involvement by offering positive, family-friendly musical entertainment; and

WHEREAS, the County deems it in the best interest of the County and the County will best be served by entering into the license agreement with the Promoter.

NOW THEREFORE, BE IT RESOLVED BY THE BOARD OF COMMISSIONERS

with Leon Tucker (the "Promoter") providing for organizing and facilitating



Section 2. This Resolution shall be immediately effective upon approval by the Board of Commissioners.






