RESOLUTION NO. 2010 -82

A RESOLUTION AUTHORIZING THE ACCEPTANCE OF CONDEMNED VEHICLES TO BE ASSIGNED TO THE POLICE DEPARTMENT FLEET IN A MANNER AS WILL BE IN THE BEST INTEREST OF THE COUNTY; TO PROVIDE AN EFFECTIVE DATE OF THIS RESOLUTION; AND FOR OTHER PURPOSES.

WHEREAS, the Clayton County Police Department Drug/Gang Violence Task Force, seized a 2006 Pontiac Grand Prix, VIN # 2G2WP552861248012 and a 2002 Dodge Intrepid, VIN #2B3HD46V12H193650 – case number J0906286, during a drug investigation; and

WHEREAS, the Clayton County Police Department did petition the District Attorney for forfeiture of said vehicle to the County; and

WHEREAS, the Superior Court of Clayton has forfeited ownership and title of said vehicle to the County under court order in case number 2009-CV-03640-8; and

WHEREAS, the Director of Fleet Maintenance has determined said vehicles are suitable for service as a county vehicles; and

WHEREAS, the Board of Commissioners deems it in the best interest of Clayton County, and the County will best be served by accepting said vehicles and assigning them to the Clayton County Police Department Narcotics and Gang Task Force to enhance law enforcement in accordance with applicable State Statutes.

NOW THEREFORE, BE IT RESOLVED BY THE BOARD OF COMMISSIONERS

OF CLAYTON COUNTY, GEORGIA AND IT IS HEREBY RESOLVED

Section 1. The Board of Commissioners hereby authorizes Clayton County, to accept title to a 2006 Pontiac Grand Prix, VIN # 2G2WP552861248012, and a 2002 Dodge Intrepid VIN # 2B3HD46V12H193650; to assign said vehicles to the Clayton County Police Department


Narcotics and Gang Task Force vehicle fleet for the purpose of enhancing law enforcement in accordance with Clayton County Superior Court order number 2009-CV-03640-8. The Directors of Central Services and Fleet Maintenance are authorized to perform all acts necessary to effect this resolution.


