RESOLUTION NO. 2010 - 119

A RESOLUTION AUTHORIZING CLAYTON COUNTY TO ENTER INTO A MEMORANDUM OF UNDERSTANDING WITH CLAYTON COUNTY BOARD OF HEALTH ON BEHALF OF THE CLAYTON COUNTY PARKS AND RECREATION DEPARTMENT PROVIDING FOR THE TERMS AND CONDITIONS UNDER WHICH THE "REDUCTION IN TOBACCO USE INITIATIVE" WILL BE CONDUCTED ON THE COUNTY'S PARK FACILITIES; TO AUTHORIZE THE CHAIRMAN TO EXECUTE THE MEMORANDUM OF UNDERSTANDING AND OTHERWISE TO PERFORM ALL OTHER ACTS NECESSARY TO ACCOMPLISH THE INTENT OF THE RESOLUTION; TO PROVIDE AN EFFECTIVE DATE OF THIS RESOLUTION; AND FOR OTHER PURPOSES.

WHEREAS, Clayton County has traditionally endorsed and supported the work of various nonprofit organizations, governmental agencies, and professional service providers located and conducting business in Clayton County for the benefit of the County's citizens; and

WHEREAS, the County has expressed interest in collaborating with the Clayton County Board of Health to facilitate and promote the "Reduction in Tobacco Use Initiative" which will be conducted from the date of execution of this resolution through December 31, 2010, or an earlier date mutually agreed to by the parties, on the County's Park facilities with the purpose of reducing the burden of disease, death, and disability related to tobacco usage; and

WHEREAS, Clayton County Board of Health is qualified to organize and facilitate projects that promote reducing the ill effects related to tobacco usage; and

WHEREAS, the Board of Commissioners deems it in the best interest of Clayton County, and the County will best be served by entering into the Memorandum of Understanding as contemplated therein.

NOW THEREFORE, BE IT RESOLVED BY THE BOARD OF COMMISSIONERS
OF CLAYTON COUNTY, GEORGIA AND IT IS HEREBY RESOLVED

Section 1. The Board of Commissioners hereby authorizes the County to enter into a Memorandum of Understanding on behalf of the Clayton County Parks and Recreation Department with the Clayton County Board of Health providing for the terms and conditions under which the "Reduction in Tobacco Use Initiative" will be conducted from the date of execution of this resolution through December 31, 2010, or a date mutually agreed to by the parties, on the County's Park facilities with the purpose of reducing the burden of disease, death, and disability related to tobacco usage. The Board of Commissioners hereby authorizes the Chairman to execute the Memorandum of Understanding and to perform all other acts necessary to accomplish the intent of this Resolution. The Memorandum of Understanding shall be in substantially the form attached hereto, subject to such minor changes, insertions or deletions as the Chairman of the Board of Commissioners may approve.

Section 2. This Resolution shall be effective on the date of its approval by the Board of Commissioners.
