ORDINANCE NO. 2009- 69

AN ORDINANCE TO AMEND SECTION 2 OF ORDINANCE NO. 2009-50 ADOPTED April 7, 2009 TO ADOPT THE CLASSIFICATION SPECIFICATIONS FOR THE POSITION OF CHIEF OF STAFF, WHICH WAS INADVERTENTLY OMMITTED FROM ORDINANCE NO. 2009-50, AND TO PROVIDE FOR THE SALARY OF THE CHIEF OF STAFF POSITION, TO PROVIDE A SOURCE OF FUNDING FOR THE SALARY INCREASE FOR THE CHIEF OF STAFF POSITION, TO AUTHORIZE THE FINANCE DIRECTOR TO AMEND THE BUDGET WHERE NECESSARY TO REFLECT AN APPROPRIATE REVENUE SOURCE AND EXPENSE TO PROVIDE AN EFFECTIVE DATE AND FOR OTHER PURPOSES.

WHEREAS, at the meeting of April 7, 2009, the Clayton County Board of Commissioners adopted Ordinance No. 2009-50, a portion of said ordinance created the position of Chief of Staff; and

WHEREAS, Section 2 of said Ordinance provided for the adoption of a Classification Specification for the position of Chief of Staff; and

WHEREAS, the Classification Specification was not attached to Ordinance No. 2009-50; and

WHEREAS, the Board of Commissioners desires to adopt a Classification Specification for the newly created position of Chief of Staff; and

WHEREAS, the Board of Commissioners further desires to establish the compensation for position of Chief of Staff, to provide funding for the salary increase for the position, to authorize the Finance Director to amend the budget where necessary to reflect an appropriate revenue source and expense; and

WHEREAS, the Board of Commissioners further desires to provide that Alex Cohilas who was appointed to fill the position of Chief of Staff on an interim basis will maintain his current position of Chief of Fire and Emergency Services in addition to serving in the position of Chief of Staff on an interim basis.

NOW THEREFORE, BE IT ORDAINED BY THE BOARD OF COMMISSIONERS OF  
CLAYTON COUNTY, GEORGIA AND IT IS HEREBY ORDAINED:

**PART I. ENACTMENT**

Section 1. The Clayton County Board of Commissioners hereby adopts the attached "Classification Specification" as the duties of the Chief of Staff position.

Section 2. The pay grade for the position of Chief of Staff shall be established by further action of the Board of Commissioners. The Board hereby establishes the pay for Alex Cohilas for so long as he serves in the capacity of Interim Chief of Staff and Chief of Fire and Emergency Services as follows:

- a) Mr. Cohilas shall continue to be paid his full salary as Chief of Fire and Emergency Services, said salary shall continue to be funded as previously provided; and
- b) Mr. Cohilas shall be paid an additional amount equal to ten (10%) percent of his prior salary for so long as he serves in the additional position of Interim Chief of Staff.

The Board of Commissioners directs that the increase in salary for the Interim Chief of Staff Appointee shall be taken from the Board of Commissioners' budget. Further, the Board of Commissioners hereby authorizes the Finance Director to amend the budget where necessary to reflect an appropriate revenue source and expense.

**PART II. EFFECTIVE DATE**


This ordinance shall become effective upon adoption by the Clayton County Board of Commissioners.

**PART III. SEVERABILITY**



**ADOPTED** by the Clayton County Board of Commissioners this 14<sup>th</sup> day of April, 2009.


