RESOLUTION 2009 – 119

A RESOLUTION AUTHORIZING CLAYTON COUNTY TO TRANSMIT THE DRAFT PARTIAL UPDATE TO CLAYTON COUNTY'S COMPREHENSIVE PLAN 2005-2025 TO THE ATLANTA REGIONAL COMMISSION FOR REVIEW AS REQUIRED BY THE GEORGIA DEPARTMENT OF COMMUNITY AFFAIRS; TO AUTHORIZE THE CHAIRMAN TO PERFORM ALL OTHER ACTS NECESSARY TO ACCOMPLISH THE INTENT OF THE RESOLUTION; TO AUTHORIZE THE FINANCE DIRECTOR TO AMEND THE BUDGET WHERE NECESSARY TO REFLECT AN APPROPRIATE REVENUE SOURCE; TO PROVIDE AN EFFECTIVE DATE OF THIS RESOLUTION; AND FOR OTHER PURPOSES.

WHEREAS, the Clayton County Board of Commissioners has completed the Draft Partial Update to Clayton County's Comprehensive Plan 2005-2025; and

WHEREAS, these documents were prepared according to the Georgia Department of Community Affairs (DCA) 2005 Local Planning Requirements and the required public hearing was held on July 27, 2009; and

WHEREAS, the DCA also requires Clayton County to submit its Draft Partial Update to the Atlanta Regional Commission for review prior to the County's adoption of the Partial Update; and

WHEREAS, the Board of Commissioners deems that it is in the best interest of Clayton County to transmit the Draft Partial Update.

NOW THEREFORE, BE IT RESOLVED BY THE BOARD OF COMMISSIONERS
OF CLAYTON COUNTY, GEORGIA AND IT IS HEREBY RESOLVED

Section 1. The Board of Commissioners hereby authorizes Clayton County to transmit the Draft Partial Update to Clayton County's Comprehensive Plan 2005-2025 to the Atlanta Regional Commission as required by the Georgia DCA. The Board of Commissioners hereby authorizes the Chairman to perform all other acts necessary to accomplish the intent of this Resolution. The Board of Commissioners further authorizes the Finance Director to amend the budget where necessary to reflect an appropriate revenue source and expense, all as may be required under DCA regulations.

Section 2. This Resolution shall be effective on the date of its approval by the Board of Commissioners.




