RESOLUTION NO. 2009 - 123

A RESOLUTION AUTHORIZING CLAYTON COUNTY TO ENTER INTO A GRANTEE AGREEMENT, ON BEHALF OF THE CLAYTON COUNTY COOPERATIVE EXTENSION SERVICE, WITH THE UNITED WAY OF METROPOLITAN ATLANTA AND IN ACCORDANCE THEREWITH ACCEPT GRANT FUNDS TO BE USED IN THE ABC'S OF PARENTING PROGRAM; TO AUTHORIZE THE CHAIRMAN TO EXECUTE THE AGREEMENT, AND OTHERWISE TO PERFORM ALL ACTS NECESSARY TO ACCOMPLISH THE INTENT OF THIS RESOLUTION; TO AUTHORIZE THE FINANCE DIRECTOR TO AMEND THE BUDGET TO REFLECT THE APPROPRIATIONS AND EXPENDITURES RELATING THERETO; TO PROVIDE AN EFFECTIVE DATE; AND FOR OTHER PURPOSES.

WHEREAS, Clayton County, through the Clayton County Cooperative Extension Service (the "Extension Service") provides parent aide services to eligible participants through the ABC's of Parenting Program; and

WHEREAS, Clayton County applied for grant funds through the United Way of Metropolitan Atlanta for the ABC's of Parenting Program and has been awarded funding in the amount of \$7,000.00 with no matching funds required from Clayton County; and

WHEREAS, the grant period is from July 1, 2009 through June 30, 2010; and

WHEREAS, the Board of Commissioners deems it in the best interest of the County, and the County will best be served by entering into a Agreement with the United Way of Metropolitan Atlanta for the stated purposes.

NOW THEREFORE, BE IT RESOLVED BY THE BOARD OF COMMISSIONERS

OF CLAYTON COUNTY, GEORGIA AND IT IS HEREBY RESOLVED

Section 1. The Board of Commissioners hereby authorizes Clayton County to enter into an Agreement, on behalf of the Clayton County Cooperative Extension Service, with the United Way of Metropolitan Atlanta and in accordance therewith accept grant funds to be used in the ABC's of Parenting Program. The Board of Commissioners authorizes the Chairman to execute the Agreement, and otherwise perform all acts necessary to accomplish the intent of this Resolution.




Section 2. This Resolution shall be effective on the date of its approval by the Board of Commissioners.


