RESOLUTION NO. 2009 - 149

A RESOLUTION AUTHORIZING CLAYTON COUNTY TO ENTER INTO A CONTRACT WITH THE COLLABORATIVE FIRM, LLC PROVIDING FOR THE TERMS AND CONDITIONS UNDER WHICH STAND-BY PLANNING SERVICES WILL BE RENDERED TO THE COUNTY; TO AUTHORIZE THE CHAIRMAN TO EXECUTE THE AGREEMENT TOGETHER WITH ANY DOCUMENTS NECESSARY TO ACCOMPLISH THE INTENT OF THIS RESOLUTION; TO AUTHORIZE THE FINANCE DIRECTOR TO AMEND THE BUDGET WHERE NECESSARY TO REFLECT AN APPROPRIATE REVENUE SOURCE AND EXPENSE, ALL AS MAY BE REQUIRED UNDER THE TERMS OF THE AGREEMENT; TO PROVIDE AN EFFECTIVE DATE OF THIS RESOLUTION; AND FOR OTHER PURPOSES.

WHEREAS, Clayton County seeks to achieve sustainable and aesthetically pleasing development through economic growth which is protective of the environmental, historic and all public resources by means of its zoning and development ordinances, planning processes, and individual site development decisions; and

WHEREAS, Clayton County desires to hire a Consultant to provide professional planning services on an as needed basis as set forth herein, to accomplish the goal stated above.

WHEREAS, the Board of Commissioners deems it in the best interest of Clayton County, and Clayton County will best be served by entering into a contract for the above stated purpose.

NOW THEREFORE, BE IT RESOLVED BY THE BOARD OF COMMISSIONERS  
OF CLAYTON COUNTY, GEORGIA AND IT IS HEREBY RESOLVED

Section 1. The Board of Commissioners hereby authorizes Clayton County to enter into a contract with the Collaborative Firm, LLC, providing for the terms and conditions under which the preparation of the Comprehensive Plan Partial Update and planning services will be rendered to the County as provided in the attached agreement, attached hereto as "Attachment A". The Board of Commissioners hereby authorizes the Chairman to execute the contract, and to perform all other acts necessary to accomplish the intent of this Resolution. Further, the Board of Commissioners hereby authorizes the Director of Finance to amend the budget where necessary to reflect an appropriate revenue source and expense, all as may be required under the terms of the contract. The contract shall be subject to such minor changes, insertions or deletions as the Chairman of the Board of Commissioners may approve consistent with the terms in the proposal.


Section 2. This Resolution shall be effective on the date of its approval by the Board of Commissioners.




