RESOLUTION NO. 2008 - 38

A RESOLUTION AUTHORIZING CLAYTON COUNTY TO ENTER INTO AN INTERGOVERNMENTAL AGREEMENT WITH THE CITY OF RIVERDALE, GEORGIA PROVIDING FOR THE TERMS AND CONDITIONS UNDER WHICH INSPECTION AND PERMITTING FOR NEW CONSTRUCTION OF CLAYTON COUNTY BOARD OF EDUCATION SCHOOLS LOCATED WITHIN THE CITY OF RIVERDALE WILL BE ADMINISTERED; TO AUTHORIZE THE CHAIRMAN TO EXECUTE THE AGREEMENT AND OTHERWISE TO PERFORM ALL OTHER ACTS NECESSARY TO ACCOMPLISH THE INTENT OF THE RESOLUTION; TO AUTHORIZE THE FINANCE DIRECTOR TO AMEND THE BUDGET WHERE NECESSARY TO REFLECT AN APPROPRIATE REVENUE SOURCE AND EXPENSE, ALL AS MAY BE REQUIRED UNDER THE TERMS OF THE AGREEMENT; TO PROVIDE AN EFFECTIVE DATE OF THIS RESOLUTION; AND FOR OTHER PURPOSES.

WHEREAS, Article 9, Section 3, Paragraph 1 of the Constitution of the State of Georgia provides that counties and municipalities may contract with each other for joint services; and

WHEREAS, Title 20, Article 2, Section 261, Subsection (d) provides that a local board of education shall be exempt from county and municipal assessment and fees for county and municipal building permits and inspections; and

WHEREAS, Clayton County and the City of Riverdale (jointly the "Parties") have determined that there is, at present and into the future, a continuing need to develop an agreement governing the inspection and permitting of schools for the benefit of the Board of Education; and

WHEREAS, the City of Riverdale has authority to perform inspections and permitting of buildings pursuant to Section 18-12 of the Riverdale Code of Ordinances; and

WHEREAS, Clayton County has authority to perform inspections and permitting of buildings pursuant to Section 18-81 of the Clayton County Code of Ordinances; and

WHEREAS, the Board of Commissioners deems it in the best interest of Clayton County, and the County will best be served by entering into an Intergovernmental Agreement with the City of Riverdale for the purposes contemplated therein.

NOW THEREFORE, BE IT RESOLVED BY THE BOARD OF COMMISSIONERS
OF CLAYTON COUNTY, GEORGIA AND IT IS HEREBY RESOLVED


Section 1. The Board of Commissioners hereby authorizes the County to enter into an Intergovernmental Agreement with the City of Riverdale providing for the terms and conditions under which inspection and permitting for new construction of Clayton County Board of Education schools located within the City of Riverdale will be administered. The Board of Commissioners hereby authorizes the Chairman to execute the Agreement and to perform all other acts necessary to accomplish the intent of this Resolution. Further, the Board of Commissioners hereby authorizes the Director of Finance to amend the budget where necessary to reflect an appropriate revenue source and expense, all as may be required under the terms of the Agreement. The Agreement shall be in substantially the form attached hereto, subject to such minor changes, insertions or deletions as the Chairman of the Board of Commissioners may approve.

Section 2. This Resolution shall be effective on the date of its approval by the Board of Commissioners.


