RESOLUTION NO. 2008 - 63

A RESOLUTION AUTHORIZING CLAYTON COUNTY TO ACCEPT A SCHOOL BUS FROM THE CLAYTON COUNTY BOARD OF EDUCATION TO BE USED BY THE CLAYTON COUNTY FIRE DEPARTMENT FOR TRANSPORTATION ; TO AUTHORIZE THE CHAIRMAN TO EXECUTE AN AGREEMENT AND BILL OF SALE, TOGETHER WITH ANY OTHER DOCUMENTS NECESSARY TO ACCOMPLISH THE INTENT OF THIS RESOLUTION; TO AUTHORIZE THE DIRECTOR OF CENTRAL SERVICES TO ADD THE BUS TO THE COUNTY'S INVENTORY FLEET; TO PROVIDE AN EFFECTIVE DATE OF THIS RESOLUTION; AND FOR OTHER PURPOSES.

WHEREAS, Clayton County Board of Education wishes to sell to the County (for the sum of \$1.00 in U.S. currency), a school bus, identified as a 1992 Navistar International, 66 passenger bus, Model #3700, VIN-1HVBZRN5NH406495, for use by the Clayton County Fire Department for transportation; and

WHEREAS, the Board of Commissioners deems it in the best interest of the County, and the County will best be served by accepting the bus from the Clayton County Board of Education for the above-stated purpose.

NOW THEREFORE, BE IT RESOLVED BY THE BOARD OF COMMISSIONERS  
OF CLAYTON COUNTY, GEORGIA AND IT IS HEREBY RESOLVED

Section 1. The Board of Commissioners hereby authorizes Clayton County to accept a bus from the Clayton County Board of Education to be used by the Clayton County Fire Department for transportation. The Board of Commissioners hereby authorizes the Chairman

to execute the Agreement and Bill of Sale, together with any other documents necessary to effectuate the intent of this resolution. Further, the Board of Commissioners authorizes the Director of Central Services to add the bus to the County's inventory fleet.

Section 2. This Resolution shall be effective on the date of its approval by the Board of Commissioners.






