RESOLUTION NO. 2008 -

A RESOLUTION TO PROVIDE FOR THE ESTABLISHMENT OF THE CLAYTON COUNTY ADOPT-A-ROAD PROGRAM; TO AUTHORIZE THE CHAIRMAN AND THE DIRECTOR OF THE TRANSPORTATION AND DEVELOPMENT DEPARTMENT TO EXECUTE A RELATED FORM CONTRACT, AND OTHERWISE PERFORM ALL OTHER ACTS NECESSARY TO ACCOMPLISH THE INTENT OF THIS RESOLUTION; AND TO PROVIDE AN EFFECTIVE DATE OF THIS RESOLUTION; AND FOR OTHER PURPOSES.

WHEREAS, the Board of Commissioners recognizes the need and desirability of litter-free roads in the County; and

WHEREAS, the Board of Commissioners has previously approved the "Adopt-A-Road" Program in the unincorporated portions of Clayton County (the "Program"), which facilitates the contribution by civic and non-profit organizations and other interested parties to the effort of maintaining litter-free roads; and

WHEREAS, Keep Clayton County Beautiful, Inc. (the "Promoter") is qualified to organize and manage the Program, and the Director of the County's Transportation and Development Department recommends that the Promoter be authorized to organize and manage the Program; and

WHEREAS, the Promoter's staff has drafted a blank contract to be signed by member organizations for use in the Program, and which requires the signature of the Director of Transportation and Development and the Chairman of the Board of Commissioners;

WHEREAS, it appears to be in the best interest of the citizens of Clayton County, and the County will best be served by establishing the Clayton County "Adopt-A-Road" Program for the purpose above-mentioned.

NOW THEREFORE, BE IT RESOLVED BY THE BOARD OF COMMISSIONERS  
OF CLAYTON COUNTY, GEORGIA AND IT IS HEREBY RESOLVED

Section 1. The Board of Commissioners hereby establishes the Clayton County "Adopt-A-Road" Program and authorizes Keep Clayton County Beautiful, Inc. to organize and manage the Program.

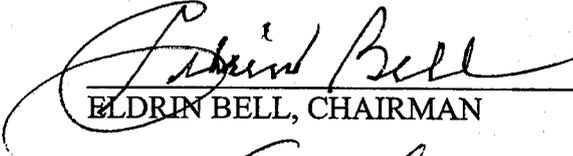

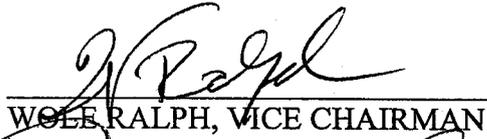
Section 3. This Resolution shall become effective upon its approval by the Board of Commissioners.

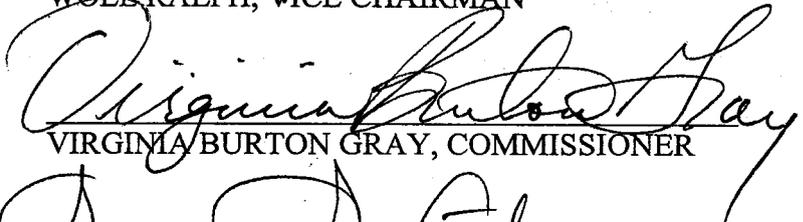

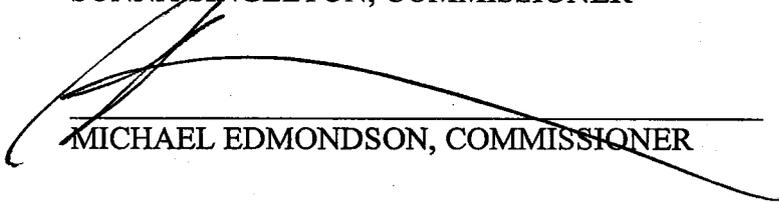
