RESOLUTION NO. 2008 – 85

A RESOLUTION AUTHORIZING CLAYTON COUNTY TO EXERCISE ITS POWERS OF EMINENT DOMAIN IN ACCORDANCE WITH PROVISIONS OF GA. LAWS FOR THE PURPOSE OF ACQUIRING CERTAIN PROPERTIES FOR USE BY THE CLAYTON COUNTY TRANSPORTATION AND DEVELOPMENT DEPARTMENT FOR THE NORMAN DRIVE, WEST FAYETTEVILLE ROAD, SR 314 AND RIVERDALE ROAD PROJECT; TO AUTHORIZE THE CHAIRMAN TO EXECUTE ANY DOCUMENTS RELATING THERETO, AND OTHERWISE TO PERFORM ALL ACTS NECESSARY TO ACCOMPLISH THE INTENT OF THIS RESOLUTION; TO PROVIDE AN EFFECTIVE DATE OF THIS RESOLUTION; AND FOR OTHER PURPOSES.

WHEREAS, Clayton County is acquiring ownership and/or permanent and temporary easements for approximately 27 parcels associated with the Norman Drive, West Fayetteville Road, SR 314 and Riverdale Road SPLOST project; and

WHEREAS, the County has attempted to acquire certain property, but has been unable to do so for various reasons, therefore it is necessary to obtain through the use of condemnation(s); and

WHEREAS, the County desires to exercise its powers of eminent domain in accordance with provisions of Ga. Laws for the purpose of acquiring certain properties for use by the Clayton County Transportation and Development Department's Norman Drive, West Fayetteville Road, SR 314 and Riverdale Road SPLOST project, specifically S&A Food & Gas, Inc., tax identification no(s).13071CA004; Eddie A. Gilbert Jr., tax identification no(s). 13090BC001; Christian Fellowship Baptist Church, Inc., tax identification no(s).13090BA002 & 13090BA001; Emmanuel House of Prayer & Word of Truth, tax identification no(s). 13089AA012; Syana Ouy, tax identification no(s). 13089AA007; Paul R. WHEREAS, the Board of Commissioners deems it in the best interest of Clayton County, and the County will best be served by acquiring subject properties for the reasons set forth herein.

NOW THEREFORE, BE IT RESOLVED BY THE BOARD OF COMMISSIONERS
OF CLAYTON COUNTY, GEORGIA AND IT IS HEREBY RESOLVED


Section 1. The Board of Commissioners hereby authorizes Clayton County to exercise its powers of eminent domain in accordance with provisions of Ga. Laws for the purpose of acquiring certain properties for use by the Clayton County Transportation and Development Department for the Norman Drive, West Fayetteville Road, SR 314 and Riverdale Road project, specifically S&A Food & Gas, Inc., tax identification no(s).13071CA004; Eddie A. Gilbert Jr., tax identification no(s). 13090BC001; Christian Fellowship Baptist Church, Inc., tax identification no(s).13090BA002 & 13090BA001; Emmanuel House of Prayer & Word of Truth, tax identification no(s). 13089AA012; Syana Ouy, tax identification no(s). 13089AA007; Paul R. Freeman, tax identification no(s). 13072CF003; and Milton W. and Michael E. Shlapak, tax identification no(s).13089AB001D. Further, the Board of Commissioners hereby authorizes the Chairman to execute any document relating thereto, and otherwise to perform all acts necessary to accomplish the intent of this Resolution. The properties sought to be acquired are more fully depicted on Exhibit "A" attached hereto.

Section 2. This Resolution shall be effective on the date of its approval by the Board of Commissioners.






