RESOLUTION NO. 2008 -

A RESOLUTION AUTHORIZING CLAYTON COUNTY TO ENTER INTO A MEMORANDUM OF UNDERSTANDING WITH WEST GEORGIA TECHNICAL COLLEGE ON BEHALF OF THE CLAYTON COUNTY FIRE & EMERGENCY SERVICES PROVIDING FOR THE TERMS AND CONDITIONS UNDER WHICH EXPANDED EDUCATIONAL OPPORTUNITIES FOR THE EMPLOYEES OF THE CLAYTON COUNTY FIRE & EMERGENCY SERVICES WILL BE ADMINISTERED; TO AUTHORIZE THE CHAIRMAN TO EXECUTE THE MEMORANDUM OF UNDERSTANDING AND OTHERWISE TO PERFORM ALL OTHER ACTS NECESSARY TO ACCOMPLISH THE INTENT OF THE RESOLUTION; TO AUTHORIZE THE FINANCE DIRECTOR TO PROVIDE FOR AN APPROPRIATE REVENUE SOURCE AND EXPENSE, ALL AS MAY BE REQUIRED UNDER THE TERMS OF THE MEMORANDUM OF UNDERSTANDING; TO PROVIDE AN EFFECTIVE DATE OF THIS RESOLUTION; AND FOR OTHER PURPOSES.

WHEREAS, the Clayton County Board of Commissioners (the "County") on behalf of the Clayton County Fire & Emergency Services desires to create a training plan/career development ladder for employees of the Clayton County Fire & Emergency Services through college credit instruction provided through West Georgia Technical College, (the "College"); and

WHEREAS, the College will return to the Clayton County Fire & Emergency Services the cost of instruction equivalent to the current rate of instruction paid to adjunct faculty teaching in the program; and

WHEREAS, the instructional rate shall be based upon the educational degree of each lead instructor and the number of contact hours taught; and

WHEREAS, the Clayton County Fire & Emergency Services will submit names, qualifications, and hours taught to College for proper reimbursement; and

WHEREAS, the Board of Commissioners deems it in the best interest of Clayton County, and the County will best be served by entering into the Memorandum of Understanding as contemplated therein.

NOW THEREFORE, BE IT RESOLVED BY THE BOARD OF COMMISSIONERS  
OF CLAYTON COUNTY, GEORGIA AND IT IS HEREBY RESOLVED


Section 1. The Board of Commissioners hereby authorizes the County to enter into a Memorandum of Understanding on behalf of the Clayton County Fire & Emergency Services with West Georgia Technical College providing for the terms and conditions under which expanded education opportunities for the employees for the Clayton County Fire & Emergency Services will be administered. The Board of Commissioners hereby authorizes the Chairman to execute the Memorandum of Understanding and to perform all other acts necessary to accomplish the intent of this Resolution. Further, the Board of Commissioners hereby authorizes the Director of Finance to provide for an appropriate revenue source and expense, all as may be required under the terms of the Memorandum of Understanding. The Memorandum of Understanding shall be in substantially the form attached hereto, subject to such minor changes, insertions or deletions as the Chairman of the Board of Commissioners may approve.


Section 2. This Resolution shall be effective on the date of its approval by the Board of Commissioners.




