RESOLUTION 2008 - 127

A RESOLUTION TO AMEND RESOLUTION 2007-55, THEREBY AUTHORIZING THE CLAYTON COUNTY DEPARTMENT OF COMMUNITY DEVELOPMENT TO ESTABLISH NEW FEES; TO AUTHORIZE THE CHAIRMAN TO EXECUTE ALL NECESSARY DOCUMENTS AND OTHERWISE TO PERFORM ALL OTHER ACTS NECESSARY TO ACCOMPLISH THE INTENT OF THE RESOLUTION; TO PROVIDE AN EFFECTIVE DATE OF THIS RESOLUTION; AND FOR OTHER PURPOSES.

WHEREAS, in March 2007 via Resolution 2007-55 the Board of Commissioners established certain fees related to the Planning and Zoning Division of the Department of Community Development; and

WHEREAS, the Board of Commissioners wishes to establish new fees as they relate to the Planning and Zoning Division; and

WHEREAS, the Board of Commissioners deems it in the best interest of Clayton County, and the County will best be served by authorizing the following fees:

Cell/Communications Tower Planning Review

New Tower: \$750.00

Co-Location: \$450.00

Fence Permit

Less than or equal to 1,000 linear feet: \$25.00

Greater than 1,000 linear feet: \$50.00

Copy of Zoning Ordinance

\$50.00

Tree Harvesting Permit

\$50.00 minimum (\$1.00 per acre)

Commercial Plan Review

\$300.00 minimum (\$5.00 per acre)

NOW THEREFORE BE IT RESOLVED BY THE BOARD OF COMMISSIONERS OF
CLAYTON COUNTY, GEORGIA AND IT IS HEREBY RESOLVED


Section 1. The Board of Commissioners hereby authorizes the Planning and Zoning Division of the Department of Community Development to establish those new fees as set forth above, which fees shall be in addition to or in place of those fees approved via Resolution 2007-55. The Board of Commissioners authorizes the Chairman to execute any necessary documents, and to otherwise perform all acts necessary to accomplish the intent of this Resolution.

Section 2. This Resolution shall be effective on the date of its approval by the Board of Commissioners.
