RESOLUTION NO. 2008 - 168

A RESOLUTION TO PROVIDE FOR AN INCREASE IN THE LEVEL OF COMPENSATION PAYABLE TO THE CHAIRPERSON AND MEMBERS OF THE CLAYTON COUNTY CIVIL SERVICE BOARD FOR SERVICES RENDERED IN THEIR OFFICIAL CAPACITIES; TO AUTHORIZE THE CHAIRMAN TO PERFORM ALL ACTS NECESSARY TO ACCOMPLISH THE INTENT OF THE RESOLUTION; TO AUTHORIZE THE FINANCE DIRECTOR TO AMEND THE BUDGET WHERE NECESSARY TO REFLECT AN APPROPRIATE REVENUE SOURCE AND EXPENSE, ALL AS MAY BE REQUIRED; TO PROVIDE AN EFFECTIVE DATE OF THIS RESOLUTION; TO REPEAL CONFLICTING RESOLUTIONS , AND FOR OTHER PURPOSES.

WHEREAS, the Board of Commissioners appoints members to various County Boards and Authorities to assist the County in numerous governmental functions and related endeavors; and

WHEREAS, the Board of Commissioners desires to increase the compensation for the Clayton County Civil Service Board Chairperson from \$225.00 to \$325.00, per month and provide compensation of an additional \$25.00 for each additional meeting, not to exceed two additional meetings, per month; and

WHEREAS, the Board of Commissioners desires to increase the compensation for the Clayton County Civil Service Board Members from \$200.00 to \$300.00, per month, and provide compensation of an additional \$25.00 for each additional meeting held during the month; and

WHEREAS, the Board of Commissioners deems it in the best interest of Clayton County and the County will best be served by providing an increase in the level of compensation commensurate with the degree of services rendered by the Chairperson and Members of the Clayton County Civil Service Board.

NOW THEREFORE, BE IT RESOLVED BY THE BOARD OF COMMISSIONERS  
OF CLAYTON COUNTY, GEORGIA AND IT IS HEREBY RESOLVED

Section 1. Except as specifically provided by Georgia Laws, or other County enacted resolutions setting levels of compensation, the Board of Commissioners hereby establishes and sets the level of compensation payable to the Chairperson of the Clayton County Civil Service Board at \$325.00, per month and other members of the Clayton County Civil Service Board at \$300.00, per month. Further, the Chairman and each member shall be paid an additional \$25.00 for each additional meeting, not to exceed two additional meetings, held during the month. All shall be payable per month in arrears. Additionally, the Board of Commissioners hereby authorizes the payment of reasonable expenses necessarily incurred during attendance for State of Georgia mandated education or training in such manner as other County employees are paid for job related expenses.

Section 2. The Board of Commissioners hereby authorizes the Chairman to perform all acts necessary to accomplish the intent of this Resolution. Further, the Board of Commissioners hereby authorizes the Director of Finance to amend the budget where necessary to reflect an appropriate revenue source and expense, all as may be required.

Section 3. This Resolution shall be effective on the date of its approval by the Board of Commissioners.


