RESOLUTION NO. 2008 - 206

A RESOLUTION AUTHORIZING THE REORGANIZATION OF THE GREENSPACE OFFICE OF TRANSPORTATION AND DEVELOPMENT; TO AUTHORIZE THE CHAIRMAN TO PERFORM ALL ACTS NECESSARY TO ACCOMPLISH THE INTENT OF THE RESOLUTION; TO AUTHORIZE THE FINANCE DIRECTOR TO AMEND THE BUDGET WHERE NECESSARY TO REFLECT AN APPROPRIATE REVENUE SOURCE AND EXPENSE; TO AUTHORIZE THE DIRECTOR OF HUMAN RESOURCES TO PERFORM ALL ACTS NECESSARY TO ACCOMPLISH THE INTENT OF THIS RESOLUTION; TO PROVIDE AN EFFECTIVE DATE OF THIS RESOLUTION; AND FOR OTHER PURPOSES.

WHEREAS, the Greenspace Office of the Transportation and Development Department presently performs several functions on behalf of the county, including but not limited to, managing and administering the County's greenspace program, which program is aimed at protecting the County's flood plains, wetlands, and areas near streams, as well as promoting bike and walking trails that link various greenspace areas throughout the county; and

WHEREAS, the Greenspace Office also provides support for the Greenspace Trust Board; and

WHEREAS, the Board of Commissioners have determined that the functions of the Greenspace Office should be separated from the Transportation and Development department by transferring the Greenspace Office functions to the Parks and Recreation

Department; and

WHEREAS, the Board of Commissioners deems it in the best interest of Clayton County and the County will best be served by approving the reorganization of the Greenspace Office by reassigning its functions and oversight to the Parks and Recreation Department as set forth below.

NOW THEREFORE, BE IT RESOLVED BY THE BOARD OF COMMISSIONERS
OF CLAYTON COUNTY, GEORGIA AND IT IS HEREBY RESOLVED

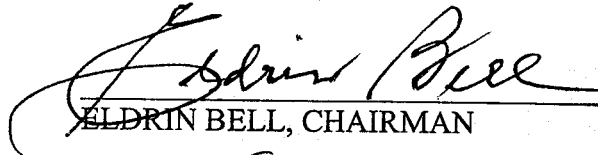
Section 1. The Board of Commissioners hereby authorizes the County to reorganize the Greenspace Office of the Transportation and Development Department whereby those functions and oversight of same will become the responsibility of the Parks and Recreation Department including the equipment and personnel associated with the office. The Board of Commissioners hereby authorizes the Chairman to perform all acts necessary to accomplish the intent of this Resolution. Further, the Board of Commissioners hereby authorizes the Director of Finance to amend the budget where necessary to reflect an appropriate revenue source and expense. The Board of Commissioners hereby further authorizes the Director of Personnel to perform all acts necessary to accomplish the intent of this resolution.

Section 2. This Resolution shall be effective on the 18th day of Nov., 2008.

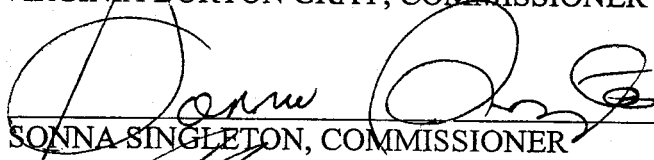

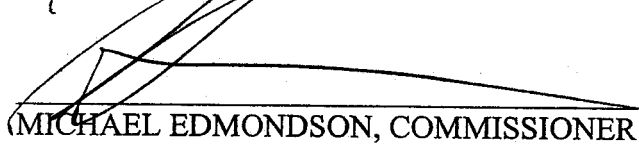

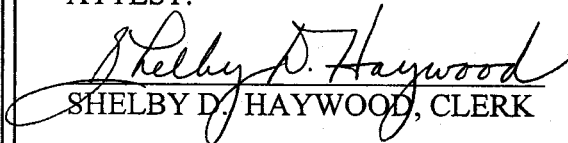
