RESOLUTION NO. 2008 - 218

A RESOLUTION WHICH ESTABLISHES A POLICY FOR ALLOWING NON-CONTRACTED TENNIS INSTRUCTORS TO PERFORM PRIVATE TENNIS LESSONS AT THE CLAYTON COUNTY TENNIS CENTER, AND RELATED FEES; TO AUTHORIZE THE CHAIRMAN TO EXECUTE ANY DOCUMENTS NECESSARY AND OTHERWISE TO PERFORM ALL OTHER ACTS NECESSARY TO ACCOMPLISH THE INTENT OF THE RESOLUTION; TO PROVIDE AN EFFECTIVE DATE OF THIS RESOLUTION; AND FOR OTHER PURPOSES.

WHEREAS, the Clayton County Board of Commissioners recognizes the desire for certain residents to utilize independent tennis instructors for private individual and/or team lessons to be conducted at the Clayton County Tennis Center; and

WHEREAS, the Clayton County Parks and Recreation Department's current Rules and Regulations do not allow tennis instructors not under contract with Clayton County to perform private individual or team lessons at the Clayton County Tennis Center, including hitting and playing lessons; and

WHEREAS, the Clayton County Parks and Recreation Department will require all tennis instructors not under contract with Clayton County, as well as their clients, who wish to use the Clayton County Tennis Center to sign a personal injury waiver; and

WHEREAS, the County desires to adopt a policy that incorporates personal injury waivers for non-contracted tennis instructors (the "Policy") to perform private tennis lessons at the Clayton County Tennis Center; and

WHEREAS, in addition to mandatory court fees established per the Parks and Recreation Department's Rules and Regulations, the Policy will set forth a separate schedule of user fees in the amounts of \$30 per lesson for individuals and \$510 per team (which total

includes nine lessons, 1.5 hours each lesson) to utilize the Clayton County Tennis Center;
and

WHEREAS, the Board of Commissioners deems it in the best interest of Clayton County, and the County will best be served by adopting the Policy as contemplated therein.

NOW THEREFORE, BE IT RESOLVED BY THE BOARD OF COMMISSIONERS OF
CLAYTON COUNTY, GEORGIA AND IT IS HEREBY RESOLVED

Section 1. The Board of Commissioners hereby establishes that it is the policy of Clayton County's Parks and Recreation Department to allow tennis instructors not under contract with Clayton County to perform private individual and/or team lessons at the Clayton County Tennis Center in exchange for a user fee of \$30 per lesson for individuals and/or \$510 per team (which total includes nine lessons, 1.5 hours each lesson), which user fee is separate and apart from mandatory court fees. Under this policy, the Parks and Recreation Department will require all such tennis instructors and their clients to execute personal injury waivers. The Board of Commissioners hereby authorizes the Chairman to execute any documents necessary and otherwise to perform all other acts necessary to accomplish the intent of the Resolution.

Section 2. This Resolution shall be effective on the date of its approval by the Board of Commissioners.


