RESOLUTION NO. 2007 - 24

A RESOLUTION AUTHORIZING THE REORGANIZATION OF THE CLAYTON COUNTY COMPUTER CENTER, TECHNICAL SUPPORT, AND ARCHIVES AND RECORDS TO BE COMBINED AS THE DEPARTMENT OF INFORMATION TECHNOLOGY; TO AUTHORIZE THE CHAIRMAN TO PERFORM ALL OTHER ACTS NECESSARY TO ACCOMPLISH THE INTENT OF THE RESOLUTION; TO AUTHORIZE THE FINANCE DIRECTOR TO AMEND THE BUDGET WHERE NECESSARY TO REFLECT AN APPROPRIATE REVENUE SOURCE AND EXPENSE; TO AUTHORIZE THE DIRECTOR OF PERSONNEL TO PERFORM ALL ACTS NECESSARY TO ACCOMPLISH THE INTENT OF THIS RESOLUTION. TO PROVIDE AN EFFECTIVE DATE OF THIS RESOLUTION; AND FOR OTHER PURPOSES.

WHEREAS, the Board of Commissioners wish to unify the Computer Center, Technical Support, and Archives and Records Departments into the Department of Information Technology; and

WHEREAS, the Director of the Computer Center would become the Director of the Department of Information Technology; and

WHEREAS, the Board of Commissioners deems it in the best interest of Clayton County, and the County will best be served by approving the unification of the Computer Center, Technical Support, and Archives and Records Departments into the Department of Information Technology.

NOW THEREFORE, BE IT RESOLVED BY THE BOARD OF COMMISSIONERS  
OF CLAYTON COUNTY, GEORGIA AND IT IS HEREBY RESOLVED


Section 1. The Board of Commissioners hereby authorizes the unification of the Computer Center, Technical Support, and Archives and Records Departments into the Department of Information Technology with the Director of the Computer Center becoming the Director of the

Department of Information Technology. Brett Lavender shall serve as Interim Director of the new department until a permanent Director is selected. Further the Board of Commissioners authorizes the elimination of the position Manager of Technical support and further authorizes the creation of a position to manage Archives and Records at a pay grade of 30. The Board of Commissioners hereby authorizes the Chairman to perform all other acts necessary to accomplish the intent of this Resolution. Further, the Board of Commissioners hereby authorizes the Director of Finance to amend the budget where necessary to reflect an appropriate revenue source and expense. The Board of Commissioners hereby authorizes the Director of Personnel to perform all acts necessary to accomplish the intent of this resolution.


Section 2. This Resolution shall be effective on the date of its approval by the Board of Commissioners.




