RESOLUTION NO. 2007-33

A RESOLUTION TO PROVIDE FOR A CHANGE IN THE NAMES OF CERTAIN PUBLIC ROAD RIGHT-OF-WAYS; TO AUTHORIZE THE CHAIRMAN TO EXECUTE ANY REQUIRED DOCUMENT AND OTHERWISE TO PERFORM ALL OTHER ACTS NECESSARY TO ACCOMPLISH THE INTENT OF THE RESOLUTION; TO PROVIDE AN EFFECTIVE DATE OF THIS RESOLUTION; AND FOR OTHER PURPOSES.

WHEREAS, the Board of Commissioners deems it in the best interest of Clayton County, and the County will best be served by renaming the public road right-of-ways of Sullivan Road (section of Clark Howell Highway to Riverdale Road) to Forest Parkway, Ellenwood Road (section of Highway 42 to Bouldercrest Road) to Forest Parkway, Vanchat Street (section of Flint River Road to Webb Road) to Thomas Road and Flint River Road a.k.a. Old Flint River Road (section of Webb Road to Highway 85) to Thomas Road.

NOW THEREFORE, BE IT RESOLVED BY THE BOARD OF COMMISSIONERS
OF CLAYTON COUNTY, GEORGIA AND IT IS HEREBY RESOLVED

Section 1. The Board of Commissioners hereby authorizes Clayton County to rename the public road right-of-ways of Sullivan Road (section of Clark Howell Highway to Riverdale Road) to Forest Parkway, Ellenwood Road (section of Highway 42 to Bouldercrest Road) to Forest Parkway, Vanchat Street (section of Flint River Road to Webb Road) to Thomas Road and Flint River Road a.k.a. Old Flint River Road (section of Webb Road to Highway 85) to Thomas Road. The Board of Commissioners hereby authorizes the Chairman to


execute any required documents and otherwise to perform all other acts necessary to accomplish the intent of this Resolution.

Section 2. The Clerk of the Board of Commissioners is hereby requested to notify all those property owners located on the affected road right-of-ways of the changes in names, and to ask that all interested County Departments take appropriate action to amend the maps, signs, and records of Clayton County to reflect this name change.

Section 3. This Resolution shall be effective on March 1, 2007

SO RESOLVED, this the 20th day of February, 2007.




