RESOLUTION 2007 – 102

A RESOLUTION AUTHORIZING THE CLAYTON COUNTY DEPARTMENT OF TRANSPORTATION AND DEVELOPMENT TO DEMOLISH A COUNTY OWNED HOUSE LOCATED AT 1536 WESTWOOD WAY, MORROW, GEORGIA, 30260-1132 ON BEHALF OF THE CLAYTON COUNTY DEVELOPMENT AUTHORITY; TO AUTHORIZE THE FINANCE DIRECTOR TO AMEND THE BUDGET TO REFLECT THE APPROPRIATIONS AND EXPENDITURES RELATING THERETO; TO PROVIDE AN EFFECTIVE DATE OF THIS RESOLUTION; AND FOR OTHER PURPOSES.

WHEREAS, Clayton County (the "County") is the owner of property located at 1536 Westwood Way, Morrow, Georgia, 30260-1132; and

WHEREAS, the house located on this property is in such a deteriorating and uninhabitable condition that its demolition has become necessary; and

WHEREAS, the Clayton County Development Authority has requested assistance in the form of in-kind services for the demolition of this property from the Clayton County Department of Transportation and Development; and

WHEREAS, the County deems it in its best interest of the County and the County will be best served by allowing the Clayton County Department of Transportation and Development to provide in-kind services consisting of the demolition of the house located at 1536 Westwood Way, Morrow, Georgia, 30260-1132.

NOW THEREFORE, BE IT RESOLVED BY THE BOARD OF COMMISSIONERS OF CLAYTON COUNTY AND IT IS HEREBY RESOLVED


Section 1. The Board of Commissioners authorizes the Clayton County Department of Transportation and Development to provide in-kind services consisting of

the demolition of a house located at 1536 Westwood Way, Morrow, Georgia, 30260-1132. The Board of Commissioners authorizes the Director of Finance to amend the County's current fiscal budget where necessary to reflect an appropriate revenue source and expense, and to transfer any required funds, all as may be required to complete said demolition.

Section 2. The effective date of this Resolution shall be when approved by the Board of Commissioners of Clayton County.




