RESOLUTION NO. 2007 - 94

A RESOLUTION AUTHORIZING CLAYTON COUNTY TO ENTER INTO A LICENSE AGREEMENT WITH REACH THEM 2 TEACH THEM FOUNDATION PROVIDING FOR THE TERMS AND CONDITIONS UNDER WHICH THE "RECLAIMING OUR COMMUNITY & SCHOOLS" PROJECT WILL BE CONDUCTED AT THE CLAYTON COUNTY INTERNATIONAL PARK; TO AUTHORIZE THE CHAIRMAN TO EXECUTE THE AGREEMENT, AND OTHERWISE PERFORM ALL OTHER ACTS NECESSARY TO ACCOMPLISH THE INTENT OF THIS RESOLUTION; TO PROVIDE AN EFFECTIVE DATE OF THIS RESOLUTION; AND FOR OTHER PURPOSES.

WHEREAS, Clayton County has traditionally endorsed and financially supported the work of various non-profit organizations, governmental agencies, and professional service providers located and conducting business in Clayton County for the benefit of the County's citizens; and

WHEREAS, the County has expressed interest in collaborating with Reach Them 2 Teach Them Foundation to facilitate on August 4, 2007 the "Reclaiming Our Community & Schools" project, also known as Georgia R.O.C.S., a one-day event to be held at the Clayton County International Park and consisting of a public forum in which elected officials and departments within Clayton County government address residents of the community about ways in which they service the needs of the community; and

WHEREAS, Reach Them 2 Teach Them Foundation is qualified to organize and facilitate projects that promote community empowerment and inspire excellence in education; and

WHEREAS, the County deems it in the best interest of the County and the County will best be served by entering into the agreement with the Reach Them to Teach Them Foundation.

NOW THEREFORE, BE IT RESOLVED BY THE BOARD OF COMMISSIONERS
OF CLAYTON COUNTY AND IT IS HEREBY RESOLVED




Section 2. This Resolution shall be immediately effective upon approval by the Board of Commissioners.






