RESOLUTION NO. 2007 – 152

A RESOLUTION AUTHORIZING CLAYTON COUNTY TO ISSUE A ONE-TIME MONETARY BONUS PAYMENT AS RECOMMENDED BY THE OFFICE OF CHILD SUPPORT SERVICES TO ELIGIBLE STAFF IN THE CLAYTON COUNTY DISTRICT ATTORNEY'S OFFICE; TO AUTHORIZE THE FINANCE DIRECTOR TO AMEND THE BUDGET WHERE NECESSARY TO REFLECT AN APPROPRIATE REVENUE SOURCE AND EXPENSE; TO PROVIDE AN EFFECTIVE DATE OF THIS RESOLUTION; AND FOR OTHER PURPOSES.

WHEREAS, Georgia Department of Human Resources, Office of Child Support Services is rewarding eligible state staff with a one-time monetary bonus payment in recognition of their effort in improvements made to the Child Support Enforcement program in FY' 07; and

WHEREAS, the Georgia Department of Human Resources is unable to issue salary payments to non-state employees; and

WHEREAS, the Georgia Department of Human Resources, Office of Child Support Services has authorized a \$300.00 bonus payment to eligible non-state employees that will receive payment from a local payment source; and

WHEREAS, payment of the bonus is 100% reimbursable by the State Office of Child Support Services for ten (10) employees in the Clayton County District Attorney's Office; and

WHEREAS, the Board of Commissioners deems it in the best interest of the County, and the County will be best served by issuing a \$300.00 one-time monetary bonus payment to said employees for the stated reasons.


NOW THEREFORE, BE IT RESOLVED BY THE BOARD OF COMMISSIONERS OF
CLAYTON COUNTY, GEORGIA AND IT IS HEREBY RESOLVED

Section 1. The Board of Commissioners hereby authorizes the issuance of a \$300.00 one-time monetary bonus payment for ten (10) employees of the Clayton County District Attorney's Office with the payment bonus being 100% reimbursable by the Georgia Department of Human Resources, Office of Child Support Services in the total amount of \$3000.00. Further, the Board of Commissioners hereby authorizes the Director of Finance to amend the budget where necessary to reflect an appropriate revenue source and expense, all as may be required.


Section 2. This Resolution shall be effective on the date of its approval by the Board of Commissioners.


