RESOLUTION NO. 2010 - 88

A RESOLUTION AUTHORIZING CLAYTON COUNTY TO ACCEPT A WATER PLAY STRUCTURE DONATED BY DREAMPARK INTERNATIONAL TO BE USED IN CONJUNCTION WITH THE CLAYTON COUNTY PARKS AND RECREATION DEPARTMENT'S BUSINESS OPERATIONS; TO AUTHORIZE THE CHAIRMAN TO PERFORM ALL ACTS NECESSARY TO ACCOMPLISH THE INTENT OF THIS RESOLUTION; TO AUTHORIZE THE FINANCE DIRECTOR TO AMEND THE BUDGET WHERE NECESSARY TO REFLECT APPROPRIATIONS AND EXPENDITURES RELATING THERETO; TO PROVIDE AN EFFECTIVE DATE OF THIS RESOLUTION; AND FOR OTHER PURPOSES.

WHEREAS, Clayton County desires to accept a water play structure donated by Dreampark International, to be installed by County personnel on the Beach at the Clayton County International Park and used in conjunction with Clayton County Parks and Recreation Department daily business; and

WHEREAS, the Board of Commissioners deems it in the best interest of Clayton County, and the County will best be served by accepting the water play structure for the above-stated purpose.

NOW THEREFORE, BE IT RESOLVED BY THE BOARD OF COMMISSIONERS

OF CLAYTON COUNTY, GEORGIA AND IT IS HEREBY RESOLVED



Further, the Board of Commissioners authorizes the Finance Director to amend the budget where necessary to reflect appropriations and expenditures relating thereto.


Section 2. This Resolution will be effective on the date of its approval by the Board of Commissioners.




