RESOLUTION NO. 2010 - 213

A RESOLUTION AUTHORIZING THE RENTAL OF SPACE BY CLAYTON COUNTY TO ALLOW CLARK ATLANTA UNIVERSITY TO SPONSOR AND HOST A CROSS COUNTRY RACE AT THE CLAYTON COUNTY INTERNATIONAL PARK; TO AUTHORIZE THE CHAIRMAN TO PERFORM ALL ACTS NECESSARY TO ACCOMPLISH THE INTENT OF THIS RESOLUTION; TO PROVIDE AN EFFECTIVE DATE OF THIS RESOLUTION; AND FOR OTHER PURPOSES.

WHEREAS, Clayton County has traditionally supported the work of various non-profit organizations, governmental agencies, and professional service providers located and conducting business in Clayton County for the benefit of the County's citizens; and

WHEREAS, Clark Atlanta University (the "Promoter") desires to rent the Open Field Area and park trails at the Clayton County International Park to sponsor and host on October 27, 2010 a National Collegiate Athletic Associate (NCAA) Division II cross country race, which will consist of six colleges; and

WHEREAS, the Promoter shall have sole responsibility for organizing, promoting and managing these track and field events, with no capital expense to Clayton County; and

WHEREAS, the Promoter is qualified to organize, promote and manage such event; and

WHEREAS, the County deems it in the best interest of the County and the County will best be served by allowing the Promoter to present this event.

NOW THEREFORE, BE IT RESOLVED BY THE BOARD OF COMMISSIONERS

OF CLAYTON COUNTY AND IT IS HEREBY RESOLVED



Section 2. The Board of Commissioners authorizes the Chairman to perform any acts necessary to accomplish the intent of this Resolution.


Section 3. This Resolution shall be immediately effective upon approval by the Board of Commissioners.

SO RESOLVED, this the 19th day of October, 2010.




