RESOLUTION NO. 2018-35

A RESOLUTION OF THE BOARD OF COMMISSIONERS OF CLAYTON COUNTY, GEORGIA TO SUPPORT A BIKE SAFETY RODEO IN CONJUNCTION WITH “A TASTE OF CLAYTON ARTS, MUSIC AND FOOD FESTIVAL” PRESENTED BY COMMISSIONER FELICIA FRANKLIN WARNER AND THE CLAYTON COUNTY PARKS AND RECREATION DEPARTMENT; TO AUTHORIZE THE CHAIRMAN TO PERFORM ALL ACTS NECESSARY TO ACCOMPLISH THE INTENT OF THIS RESOLUTION; TO PROVIDE AN EFFECTIVE DATE OF THIS RESOLUTION; AND FOR OTHER PURPOSES.

WHEREAS, Commissioner Felicia Franklin Warner will present the second annual “A Taste of Clayton Arts, Music and Food Festival” to showcase Clayton County and the County’s many cultural gems, businesses, musicians, and artists on Friday, May 4, 2018 and Saturday, May 5, 2018, at the South Clayton Recreation Center located at 1837 McDonough Road, Hampton, Georgia 30228; and

WHEREAS, Commissioner Felicia Franklin Warner will present a Bike Safety Rodeo (“Rodeo”) to take place in conjunction with “A Taste of Clayton Arts, Music and Food Festival”; and

WHEREAS, the Rodeo will be held on Saturday, May 5, 2018 from 9 a.m. to 12 p.m. and will be held at the Gerald Matthews complex located at the South Clayton Recreation Center at 1837 McDonough Road, Hampton, Georgia 30228; and

WHEREAS, the Rodeo is sponsored by the Girl Scouts of America, Project Safe Kids, Amerigroup and the Clayton County Board of Health; and

WHEREAS, the Clayton County Parks and Recreation Department will work in conjunction with Commissioner Franklin Warner to present the Rodeo; and

WHEREAS, the Clayton County Board of Commissioners deems it in the best interest of the County and the County will best be served by supporting the Rodeo in conjunction with the second annual “A Taste of Clayton Arts, Music and Food Festival.”

NOW THEREFORE, BE IT RESOLVED BY THE BOARD OF COMMISSIONERS
OF CLAYTON COUNTY AND IT IS HEREBY RESOLVED

Section 1. The Clayton County Board of Commissioners hereby supports a Bike Safety Rodeo event to take place at the Gerald Matthews complex at the South Clayton

Recreation Center located at 1837 McDonough Road, Hampton, Georgia 30228 between the hours of 9:00 a.m. and 12:00 p.m. on Saturday, May 5, 2018 in conjunction with the "A Taste of Clayton Arts, Music and Food Festival," presented by Commissioner Felicia Franklin Warner.

Section 2. The Board of Commissioners hereby authorizes the Clayton County Parks and Recreation Department to work in conjunction with the Girl Scouts of America, Project Safe Kids, Amerigroup, the Clayton County Board of Health and Commissioner Franklin Warner to present the Bike Safety Rodeo. The Board of Commissioners further authorizes the Chairman to perform all acts necessary to accomplish the intent of this Resolution.

Section 3. The effective date of this Resolution shall be when approved by the Board of Commissioners of Clayton County.


