A RESOLUTION SUPPORTING THE RENAMING OF THE CLAYTON COUNTY YOUTH FISHING DERBY AS THE NORAH “HAYES” ROBINSON FISHING TOURNAMENT FOR YOUTH; TO PROVIDE AN EFFECTIVE DATE AND FOR OTHER PURPOSES.

WHEREAS, Mr. Norah Robinson, affectionately known as “Hayes,” was a dedicated husband, devoted father, United States Army veteran and long time resident of Clayton County; and

WHEREAS, Hayes had a passion for outdoor activities, including fishing; and

WHEREAS, Hayes had a special passion and affinity for youth and loved teaching young people how to fish; and

WHEREAS, Hayes wanted young people to be involved in fishing and have the same love and passion for fishing that he had; and

WHEREAS, on April 4, 2018, Clayton County paid reverence to Hayes’ memory and, on that date, urged his family and all citizens to continue to exercise the principles that guided him; and

WHEREAS, the County has a youth fishing derby held annually in July; and

WHEREAS, the County seeks to further pay reverence to Hayes’ memory by renaming the youth fishing derby as the Norah “Hayes” Robinson Fishing Tournament for Youth; and

WHEREAS, the first annual Norah “Hayes” Robinson Fishing Tournament for Youth will take place on July 14, 2018.

NOW THEREFORE, BE IT RESOLVED BY THE BOARD OF COMMISSIONERS OF
CLAYTON COUNTY, GEORGIA, AND IT IS HEREBY RESOLVED

Section 1. The Clayton County Board of Commissioners hereby renames the Youth Fishing Derby held in July of each year as the “Norah ‘Hayes’ Robinson Fishing Tournament for Youth.”

Section 2. The Clayton County Board of Commissioners hereby proclaims that the first annual Norah “Hayes” Robinson Fishing Tournament for Youth will be held on July 14, 2018.


Section 3. This Resolution shall be effective on the date of its approval by the Board of Commissioners.

SO RESOLVED, this the 5th day of June, 2018.






