Mr. Hickson also stated the same day that he receive the papers from them he went down and file the paperwork because he was not aware that he had to have them. Inspector Green informed the Board that the County required he have a business license and he was cited for operating without a business license. Mrs. Welch asked if he was leasing and the person whom he was leasing it from did not have a business license. Mrs. Welch asked the Inspector Green if someone had a surplus of furniture and they rent a building would they have to have a business license. Inspector Green explained to her if it is in a commercial location they would have to have a business license. Mrs. Etheridge explained to Mr. Hickson that the Board would not know if he is renting the property out to other people and it is very questionable being in a commercial location. Mr. Hickson said that he has applied for a business license because he has a ten thousand dollar paint booth that he purchase and in order for him to take everything out of the building he would have to have a company in and take it down.
