Old Business	Statewide Leadership Council	The Region 3 Advisory Council Chairperson, Dianne Hiltman, reported on the May, 2021, meeting of the SWLC in Macon. The meetings are still virtual. The SWLC meetings may continue to be held virtually since there is better attendance for the meetings. It is hard for members to travel to Macon. The SWLC sent a document to DBHDD Commissioner, Judy Fitzgerald, containing the Top 3 Priorities for the state. The document contains the regional priorities from the six regional advisory councils and the Top 3 Priorities selected by the SWLC based on the regional priorities. Old Business (continued)	Region 3 Priorities	Ms. Hiltman reiterated the importance of the document the SWLC sent to DBHDD Commissioner, Judy Fitzgerald, and that Council members need to read the document to understand the differences in priorities among the six regional councils. It is important to know the Top 3 Priorities developed by the SWLC for the State of Georgia and to be familiar with the regional priorities. There are differences in priorities based on urban and rural areas. Questions were raised about how Council members can utilize the information. Suggestions were to meet with the state elected officials in each member's county and to work with other coalitions like the Behavioral Health Coalition to do advocacy with elected officials. New Business	Annual Election of Officers and Alternates to the SWLC	The Annual Election of Officers was held. After some discussion and questions about eligibility and willingness to serve, Evelyn Cunningham made a motion to accept the slate of President, Dianne Hiltman; Vice-President, Lynne Anderson; Secretary, Venessa Abram, by acclimation. Dr. Monica Hooker seconded the motion. The motion passed unanimously. The Chairperson, Dianne Hiltman appointed Tracy Urmil Marshall and Evelyn Cunningham to continue as Alternates to the SWLC.	Annual Officer Election results for FY 2022 are President, Dianne Hiltman; Vice-President, Lynne Anderson; Secretary, Venessa Abram. Chairperson Hiltman appointed Tracy Urmil Marshall and Evelyn Cunningham to serve as Alternates to the SWLC.
	RSA Reports	Gwen Craddieth, RSA for Behavioral Health, reported that Public Emergency still exists in Georgia due to COVID-19 until December 21, 2021. As long as this designation lasts, providers will be able to provide services using telehealth without having people come to offices/centers. Clayton County CSB is working with the Clayton County Police to do mobile crisis services. DBHDD is working with three vendors to provide Supportive Housing 2.0. The vendors are Assertive Community Resources, Viewpoint CSB, and Step-Up. Each of the three vendors has a designated target for the number of people they must serve. 700 plus people are being served in the Georgia Voucher Program with over 200 receiving a voucher but not connected to services. The Fulton County Superior Court, staff from Fulton County BH and staff from the Fulton County Jail are working together to reduce the number of people with mental illness being placed in the jail. In the near future, there will be a national number (#988) that people can call when experiencing a mental health crisis, feeling suicidal, etc., and ask for assistance.
