#### **New Business**

Rum Creek Lift Station Generator Purchase Recommendation: General Services Manager Marshall Maddox presented a recommendation on the Rum Creek Lift Station Generator Purchase.

The Rum Creek Lift Station is one of CCWA's largest sewer pump stations. The station collects wastewater from a large area on the south and north side of Hwy 138 on the east side of the County. Wastewater collected at the station is pumped to the Casey WRRF. The generator project is necessary due to the station upgrades in motor loads and EPD requirements for emergency backup for loss of power. The Rum Creek lift station upgrade is scheduled for completion on November 15<sup>th</sup>, 2017 and we need to have this generator project startup during the new station startup period.

### Recommendation:

Staff recommended awarding the quote to Cummins Inc. for the total lump sum not to exceed price of \$157,797 and an additional \$4,600 (two weeks) of bypass pumping from Godwin Pumps for a total project cost of \$162,397. Staff is seeking approval for the remaining funds of \$2,400 to come from General Managers Contingency fund. This award is contingent upon the vender meeting risk management requirements and allowing the General Manager to approve and sign the design build terms release form (contract).

UPON MOTION by Dr. Cephus Jackson and second by Rodney Givens, it was unanimously

RESOLVED to award the purchase of the Rum Creek Lift Station Generator to Cummins, Inc. in the amount of \$157,797.00 along with approving an additional \$4,600.00 (two weeks) of bypass pumping from Godwin Pumps for a total project cost of \$162,397.00. This also includes approval of an additional \$2,400.00 to be transferred from the General Manager's Contingency Fund for the purchase. This award is contingent upon the vendor meeting Risk Management Requirements and the General Manager signing the contract.

<u>Combination Vacuum-Jet Truck Purchase Recommendation:</u> Stormwater Program Director Kevin Osbey presented a recommendation on the Combination Vacuum-Jet Truck Purchase.

The Clayton County Water Authority Stormwater Utility's maintenance department operates with four crews. One crew concentrates on the cleaning and clearing of storm drains and structures. Currently, that crew has one 12 cubic yard capacity combination vacuum-jet truck that was purchased in December of 2007.
