9,000lb Mini-Excavator Purchase Recommendation: Stormwater Program Director Kevin Osbey presented a recommendation for a Mini-Excavator Purchase.

The Clayton County Water Authority Stormwater Utility's maintenance department operates with four crews. Two crews concentrate on the repair and replacement of damaged infrastructure, full time. Another crew also performs repair and replacements, but they concentrate mainly on road right-of-way ditch maintenance and pipe outfall ditch maintenance. The years of daily use has resulted in a structural failure in the excavator's boom. Yancey Brothers, which has a State Contract for this 4.5 Ton Excavator, submitted pricing for a Caterpillar 304 CR (Compact Radius) Excavator.

The Clayton County Water Authority Stormwater Utility's maintenance department operates with four crews. Two crews concentrate on the repair and replacement of damaged infrastructure, full time. At present time, these two crews are required to share a Compact Track Loader (CTL). CTL's are used to haul material from a dump truck to a work area. It is also used to perform final grading when preparing a property for restoration. Having both crews assigned with a CTL will improve efficiency.

W.B. Casey WRRF Biosolids Facility Owner Services Phase 1 Task Order Recommendation: Program Management and Engineering Director Kelly Taylor presented a recommendation for procurement support for the W.B. Casey WRRF Biosolids project.

In 2018, CCWA initiated the WB Casey WRRF Capacity Analysis and Plant Expansion Evaluation Project (Task Order JA-RE-18-02). This project determined that the Casey WRRF liquid trains processes are sufficiently sized for the near-term but that the biosolids facility is reaching ultimate capacity and is at the end of its useful life. A biosolids management alternatives analysis was conducted, and the recommended alternative (including anaerobic digestion and thermal drying) was included in a final Preliminary Engineering Report (PER) in November 2020. The estimated cost of construction of the new 32 MGD Biosolids Facility is \$91.1 million. In May 2021, the Georgia Environmental

Finance Authority (GEFA) approved a \$50M loan for design and construction of the Biosolids Facility and announced their intent to approve a second loan for \$50M in January 2022.

To condense the project timeline and to elicit innovation and collaboration, CCWA has elected to pursue a Progressive Design-Build Approach to the Biosolids Facility. Under this method, CCWA will have a single contract with a Design-Builder and will also have a contract with an Owner Advisor providing guidance throughout the procurement and lifecycle of the project. During the procurement phase of the project, the Owner Advisor will bring an understanding of fundamental principles and best practices relative to all aspects of procurement from both an Owner's perspective and the perspective of a Designbuilder. The Owner Advisor will work with the CCWA team to develop contract documents, determine qualification and evaluation criteria, and provide guidance during selection of the Design-Builder.

The scope of services includes the following tasks:

- Task 1 Planning and Kickoff Meeting
- Task 2 Develop the PDB Contract, Develop Request for Qualifications, Review of Statements of Qualification, Recommend Short List (November 2021 Board Meeting)
- Task 3 Develop Request for Proposal, Review Proposals
- Task 4 Recommend Design-Builder (April 2022 Board Meeting), Finalize PDB Contract
