7. New Business

### A. Director's Report:

Director Dozier informed the Board that as of August 1, there are 175,750 voters in Clayton County.

Director Dozier informed the Board that she attended a one-day Election Data Summit by the U.S. Election Assistance Commission and Pennsylvania Department of State on July 12, 2018. The purpose of the summit was focused on bringing together some of the nation's most respected election data experts to examine ways election officials can use all types of data to improve processes and inform decision making.

Director Dozier informed the Board that the county has started the demolition of the building to renovate the bunker to accommodate the IT Data Center. There has been a delay in completion due to the moving of the Archives Department and Board of Health. Construction of the Election/IT Data Center has not yet resumed, however contractors have been put in place to resume restorations in the upcoming weeks.

Director Dozier informed the Board that the Board of Elections & Registration staff attended Commissioner Hambrick's Back to School Bash which took place on July 29, 2018.

Director Dozier informed the Board that the Board of Election staff is currently preparing for Voter Registration Day held on September 25, 2018. There are collaborations underway between the Elections & Registration office and various community organization and volunteers.

Director Dozier informed the Board that at the next regular scheduled Board meeting, she will provide the poll worker training schedule, recommendation of Advanced Voting schedule, L & A Testing schedule, and appointment of a Board Member for the November General Vote Review Panel.

Director Dozier informed the Board that the Delta Sigma Theta Organization, Clayton County Office of Youth Service and the Youth Commission will be partnering with the Board of Elections & Registration for Voter Registration Day.

Board Member Pullar requested a list of Ambassadors from the Youth Commission including their name, school of attendance, and grade level.

Director Dozier informed the Board that the sample ballots will be ready towards the end of September.

Director Dozier informed the Board that Early Voting for the November General Election will commence on October 15, 2018 – November 2, 2018; The Saturday Advanced Voting Date will be on October 27<sup>th</sup>. The Board will need to establish a date for Sunday voting for the November General as well as a policy for future elections at the September Regular Scheduled Board Meeting.

Motion made by Board Member Givens to accept the Director's Report presented by Director Shauna Dozier. Seconded by Vice-Chair Foster Hall. Vote Unanimous. Motion carried.

B. Intergovernmental Agreement, City of College Park Special Election to be held on November 6, 2018.

Director Dozier informed the Board that the City of College Park would like to bind into an intergovernmental agreement with Clayton County Board of Elections & Registration to conduct their Special Election as it pertains to Senate Bill 17, which is defined as the Brunch Bill.

Director Dozier informed the Board that in order to place the Brunch Bill on the November General Ballot, the municipalities would have to make the first call in the legal organ 90 days before the Election in accordance with O.C.G.A 21-2-540(b).

Director Dozier informed the Board that College Park municipalities are shared with Fulton County. Director Dozier has reached out to the Secretary of State, Election Chief of Fulton County, and the Clayton County Attorney to work with them on how to conduct the special election.

Director Dozier notified the Board that in order to vote on the Brunch Bill on Election Day, the voters would be required to go to their city polling location. In order to vote for the November General Election candidates, the voters would be required to go to their county polling location. At Advanced Voting locations, the voter will have access to voting on the Brunch Bill, as well as the General Election candidates on two separate databases.

### C. City of Morrow Special Election to be held on November 6, 2018.

Director Dozier informed the Board that the Board of Elections & Registration is in a current Intergovernmental Agreement with the City of Morrow. The Board of Elections will conduct a dual election to include Morrow's Special Election pertaining to Senate Bill 17 also defined as the Brunch Bill.

#### D. City of Jonesboro Special Election to be held on November 6, 2018.

Director Dozier informed the Board that the City of Jonesboro has a referendum for Homestead and has decided to conduct their own election. Mr. Clark, the City Manager of Jonesboro, has showed interest in moving their polling location. Further updates will be provided at the upcoming meeting.

### E. EW1 Polling Place, East Clayton Elementary.

Director Dozier informed the Board that East Clayton Elementary School has moved to another building in the county. The current school building's name has changed and is now named Utopian Academy. The Board of Elections & Registrations will conduct a survey to conclude a recommendation to the Board for potential polling place changes, in anticipation of not moving the polling location. Director Dozier will provide a recommendation at a future meeting.

# F. Copy of Letter Received from the Lawyers' Committee for Civil Rights Under Law.

Director Dozier presented the Board with a copy of a letter from the Lawyers' Committee for Civil Rights Under Law that was sent to Secretary Kemp. No action is need on the letter. Director Dozier will provide updates to the Board as more information becomes available.

#### G. Hearing to remove felons from elector's list.

Motion made by Vice-Chair Foster-Hall to remove 76 felons from the elector's list, and accept the recommendation of excluding and tabling 3 felons until the next board meeting to be held on September 11, 2018.

#### H. County Board Compensation.

Director Dozier presented the Board with a copy of a letter reflecting a \$50 increase for Clayton County Board Members attendance to meetings in the fiscal year of 2019.
