## SPECIAL CALLED BUSINESS BOARD MEETING

- 3. Adoption of Agenda:

- 4. Public Comment: Citizens will be given a three minute maximum time limit to speak before the Board of Elections and Registration about various topics, issues, and concerns. Public comments will be limited to thirty (30) minutes. Following thirty minutes of hearing from the public, the Board of Elections and Registration will allow the remainder of citizens who have signed up to be heard at the next regular business meeting.
- 1. Marti Breen submitted the comment: I would like to know the dates and times when the Clayton County Elections Office intends to convene vote review panels. We have volunteers waiting to serve, but they would like to know when they can expect to be called.

Director Dozier informed the Board that the office has been receiving multiple request from the Democratic Party requesting duplicate information from multiple people. The office has been in contact with the local Clayton County Democratic Interim Chair and has been provided information directly to the local party as it has been done in the past.

Director Dozier informed the Board that the Clayton County Democratic Interim-Chair Sukari Johnson has provided the Vote Review Panelists and that they will be contacted directly by the office.

2. Helen Butler submitted: I have tried for the last two weeks to schedule a meeting with the Director of Elections to update on our Poll monitoring program that has been in effect since 2000 and to which Ms. Julie Houk sent a notice to all elections officials regarding the program before the June 9th primary. Additionally we have met with Chris Harvey from the Secretary of State's office. We would like to meet with Ms. Dozier to confirm our activities and to ensure the smooth interactions. However, because our calls nor emails have been returned, we are unable to ensure this smooth operation. Can the BOE give us a contact to discuss how we can ensure the smooth operation. This is nothing new, we have done these meetings each year prior to the election to ensure election officials and our team are aware of how to proceed as smoothly as possible.

Board Member Johnson remarked that there should be an understanding that there are multiple elections taking place and that the Director and the staff are extremely busy during this time.

# A. Additional Voting Locations

Director Dozier informed the Board that during the last meeting, action was taken to open a seventh advanced voting location to seek additional polling sites. However, construction is currently still underway at the Lake Spivey Recreation Center.

Director Dozier made a recommendation to the Board to utilize the Charles Griswell Senior Center as an Advanced Voting location from October 28, 2020 to October 30, 2020 with extended hours for the November General & Special Election as a result of the Lake Spivey Recreation Center's inability to be utilized as previously scheduled.

Motion made by Secretary Darlene Johnson, seconded by Treasurer Givens, to accept the recommendation made by Director Dozier to add Charley Griswell Senior Center as an Advanced Voting location beginning on October 28, 2020. Vote Unanimous. Motion carried.

B. Special Called Board and Regular Board Certification Date for November 2020

Director Dozier informed the Board that the office received an Official Election Bulletin on Friday, October 23, 2020 from the Secretary of State regarding an election timeline in which requires counties to complete certification before beginning the state mandated risk-limiting audit.

As a result Director Dozier recommended to the Board to change the Special Called & Regular Board Meeting to November 9, 2020 instead of the established date of November 12, 220 in order to be in compliance with the timeline directed by the Secretary of State's office.
