A. Certification of Special Runoff Election: County Commission, District 1- held on October

Director Dozier informed the Board that there were no issues on Election Day and all polling places opened on time.

Director Dozier informed the Board that there was a 4.26 percent voter turnout on Election Day.

Director Dozier informed the Board that in the Special Election on September 21, 2021 there was a 5.37 percent voter turnout.

Director Dozier informed the Board that there were 3 (three) Provisionals which 2 (two) were accepted and 1 (one) was rejected. All 3 (three) provisional were out of precinct.

Director Dozier informed the Board that if there aren't any questions, the office believes that the election results presented are tried and true and recommends that the Board certifies this election.

Board Member Pullar inquired about the reason for the third provisional being rejected.

Director Dozier informed the Board that the third provisional was rejected because the voter did not complete the oath.


