- A. Call of Special Election to Fill the Unexpired Term of School Board District 8 to be held September 21, 2021

Director Dozier informed the Board that the request for the Special Called Board Meeting is to recommend that the Board issue a call for a Special Election to fill the unexpired term of the Clayton County Board of Education, District 8 seat to be held simultaneously with the already established Special Election in County Commission, District 1 on September 21, 2021.

Director Dozier informed the Board that on July 19, 2021, the Clayton County Board of Education, District 8 elected official qualified to run for the County Commission, District 1 vacancy, thereby resigning from the Board of Education seat.

Director Dozier also informed the Board that the office was notified via letter from the Clayton County Public School Superintendent, Dr. Morcease Beasley that a vacancy has occurred in Board of Education, District 8.

Director Dozier informed the Board that by this recommendation, it would save the Clayton County Taxpayers money by having the election on the same day, within the same district, while using the same early voting sites as well as Election Day polling sites.

Director Dozier informed the Board that the office is within the timeframe to still hold the Special Elections simultaneously.

Director Dozier informed that Board that there are an estimated 22,424 Voters and 9 polling sites involved in the Board of Education, District 8.
