Registrar Manager Brown informed the Board that although it is not required, the office has been conducting additional Poll Worker training for our Poll Managers.

Vice Chair Johnson inquired into when Poll Worker training was held.

Registrar Manager Brown informed the Board that the last Poll Worker training class was held on April 11, 2023.

Registrar Manager Brown informed the Board that on the Agenda, there was a recommendation to enter into an Intergovernmental Agreement for the Clayton Board of Registration and Elections office to conduct the City of Lake City's Municipal Election on November 7, 2023.

Registrar Manager Brown informed the Board that on the Agenda, there was a recommendation for a Special Called Meeting to be called for April 21, 2023, at 5:30 PM to certify the Special Election Runoff.

Vice Chair Johnson commented that Community Outreach Specialist Walker is doing an amazing job with getting people registered to vote.

Registrar Manager Brown informed the Board that the numbers of inactive and active voters change constantly.

Registrar Manager Brown informed the Board that inactivity occurs when the voter is registered yet does not come out to vote.

Registrar Manager Brown informed the Board that inactive voters could become active again when they vote in an election.

Board Member Hope inquired into how long it takes for active voters to become inactive.

Registrar Manager Brown informed the Board that it takes four years for voters to become inactive and another four years before they are removed from the elector's list.

Secretary Walker inquired into whether the inactive voters are notified before they are removed from the elector's list.

Register Manger Brown informed the Board that before an inactive voter is removed from the elector's list, they are sent several notices to give the voter a chance to notify the office.

Vice Chair Johnson inquired about the Renovation of the Election Center and the completion of the HVAC system.

Registrar Manager informed the Board that the HVAC system was fixed in the Main Office located at 121 South McDonough Street, Jonesboro, GA.

Vice Chair Johnson informed the Board that she had spoken to Director Hopkins. He informed her that the renovations would not be completed by 2024, yet when completed, the office would have a new facility with no major problems.
