ESSENTIAL STEPS FOR DOING BUSINESS WITH MARTA

- Register as a vendor
 - www.itsmarta.com; click More; Click iSupplier Registration
- Get Certified
 - ➤ Businesses located in City of Atlanta, Clayton, Dekalb, Fulton Counties, must submit an application electronically through MARTA.
 - https://marta.diversitysoftware.com/
 - Businesses located in all other counties, must submit an application through GDOT.
 - GDOT's website: www.dot.ga.gov
- Create a Capability Statement
 - Make it specific
 - Keep it short (one to two pages)
- Prepare an Elevator Pitch
 - Be concise
- Check website for contract opportunities
 - www.itsmarta.com; click More; Click Current Opportunities
 - Visit website weekly



ESSENTIAL STEPS FOR DOING BUSINESS WITH MARTA

- Attend Pre-Quote/Pre-Proposal Conferences (virtual)
 - > Best way to gain a better understanding of MARTA's procurement requirements
- Submit a Quote/Proposal
 - > Read solicitation in its entirety
 - > Pay close attention to words such as Must, Shall, Will, Required, Mandatory, etc.
 - ➤ Include <u>ALL</u> required documentation
 - Double check dollar amounts
- Participate in outreach events and development workshops
 - > Self-investment
 - Networking opportunity
 - Education and Development Opportunity
- Have the Capacity and Capability to do the work
 - > Be a strong Strategic Partner
 - Employees and resources to meet the schedule
 - Qualifications to perform the scope of work
 - Financial resources for execution of the project
 - > Tangible assets required to do the work (equipment)

CONSTRUCTION & INSTALLATION PROJECTS

Traction Power
Sub-Station
Replacement
Program - Wave I



- Renovate or replace Traction Power Substations (TPSS) and Gap Breaker Stations (GBS) equipment. Integrate TPSS and GBS equipment to SCADA.
- Provide and install equipment including local control panels, transformers, rectifiers monitoring equipment, circuit breaker test panels, annunciator panels and emergency trip push buttons.
- Upgrade interior lighting, ventilation fans and heating components.

Job Order Contracting (JOC) 3.0

- JOC is an Indefinite Delivery Indefinite Quantity (IDIQ) procurement method that executes time sensitive projects on a Work Order basis
- MARTA will provide initial Design Concept/Scope; Contractor will complete design documents.
- Authority-wide projects with limited complexity: No heavy rail, low risk construction work and no work on life safety or other critical systems
