Candidate Forum District 3 Additional Questions

Tashe Allen:

- 1. If elected, what will you do to ensure that we have additional judges and court staff added in the courthouse to handle the rising number of cases?
 - a. I fully support our judges and other department heads in the court system. Whenever they bring me a request, they can count on my 100% backing. I will work to allocate resources and collaborate with relevant parties to add more judges and court staff to handle the increasing number of cases effectively.
- 2. How do you plan to reach out to the youth?
 - a. To effectively reach our youth, I understand the importance of truly understanding them. It's crucial for me to be approachable, engage in genuine conversations, listen without judgment, and build trust, rather than talking at them. To achieve this, I would implement several strategies: hosting town halls and forums focused on youth issues, visiting local schools to interact with students and discuss civic engagement, meeting the youth where they are by walking through neighborhoods, going to the parks, and recreational centers, collaborating with local youth groups to support their initiatives, and creating opportunities for youth employment and entrepreneurship through partnerships with local businesses.

- 3. How do you plan to change the image of Clayton County with highways being trashed with litter and garbage?
 - a. To address the litter problem in our community, it's essential to understand the mindset of those who litter. Often, people litter because there isn't a trash can nearby. Instead of carrying trash with them, they find it easier to leave it behind. The decision to litter is largely influenced by environmental cues what people see around them.
 - b. To change the image of Clayton County and bring national attention to us, I propose: Banning Commonly Littered Items. Many cities and states around the country have adopted, or at least debated adopting, bans on trash items that take up to 1,000 years to decompose in landfills and often end up dirtying parks, streets, and alleyways. By cutting back on materials that most commonly end up in U.S. landfills, we can work to curb littering behavior. Implementing a ban on commonly littered items will promote environmental responsibility and enhance Clayton County's image as a forward-thinking and environmentally-conscious community. This proactive approach will not only improve the quality of life for our residents but also attract national attention, showcasing Clayton County as a leader in environmental stewardship and community beautification.
- 4. What type of programs would you like to introduce to help ex-convicts be more productive and find sufficient housing, if they show improvement in citizenship?
 - a. I wouldn't introduce this program myself, but I would like to partner with, bring awareness to, and support organizations that are already providing solutions for the needs of ex-convicts. Ideally, I would like to see programs that offer job training, employment opportunities, housing assistance, mental health and counseling services, as well as mentorship and support groups. By collaborating with these organizations, we can assist exconvicts in reintegrating into society, becoming productive citizens, and reducing recidivism rates in our community.

- 5. What actions or policies have you implemented within the last 6 months to improve the quality of life for Clayton County residents?
 - a. As a first-time candidate for District Commissioner, I want to clarify that I currently don't hold the position to implement policies directly. However, I am actively involved in addressing community concerns. Over the last 6 months, I have been working closely with an organization in District 3 to gain a better understanding of our water issues. Just last week, we had a productive meeting with the president of the Clayton County Water Authority to discuss potential solutions and improvements. While I haven't implemented policies yet, I am committed to advocating for the well-being of Clayton County residents and working collaboratively to improve our community's quality of life.
- 6. Mental illness is a growing problem nationwide, sometimes leading to increased crime etc. What is your take on tackling this crisis?
 - a. Mental illness is indeed a growing concern nationwide, and it can contribute to various social issues, including increased crime rates. One of the key aspects of tackling this crisis is reducing the stigma around mental health, taking medication, and seeing a therapist in our community. By implementing these measures, I am committed to safeguarding taxpayer's money and ensuring that the residents of Clayton County and District 3 are protected from fraud and corruption.

- 10. What type of programs and efforts have you established or planned by district 3, and the county as a whole?
 - a. In District 3 and across the county, I have implemented a variety of programs and initiatives focused on community development and wellbeing. I personally hosted homeownership workshops to guide residents through the home buying process and ensure they make informed decisions. Keeping things clear, accessible, and easy to understand for everyone, including those with disabilities and non-English speakers, is crucial. I'd commit to getting back to citizens quickly, aiming to reply to calls and emails within a day. Lastly, I'd check in regularly on our plans and ensure our leaders are listening and

acting on citizen input, ensuring an inclusive and participatory community engagement process.

- 12. How would you make yourself available to the citizens and residents of your districts?
 - a. To make myself accessible to the citizens and residents of District 3, I would establish dedicated office hours where people can drop by to discuss their concerns, share their ideas, or ask questions. Additionally, I would attend community events to interact with residents in a more informal setting, hold regular open forums and town hall meetings, use digital platforms to communicate updates and gather feedback, and be responsive to phone calls and emails, aiming to reply within 24 hours. I believe that by being approachable, attending community events, and actively engaging with the community, I can better understand their needs and priorities and work collaboratively to address them.
