RESOLUTION NO. 2021-87

A RESOLUTION AUTHORIZING THE CLAYTON COUNTY TAX COMMISSIONER TO ACCEPT CHECKS, MONEY ORDERS, CERTIFIED FUNDS, CREDIT/DEBIT CARD PAYMENTS, ACH PAYMENTS, AND WIRE TRANSFERS FOR ALL TAXES FEES, AND LICENSES DUE TO THE TAX COMMISSIONER'S OFFICE; TO AUTHORIZE THE CHAIRMAN TO EXECUTE ANY DOCUMENTS AND TO OTHERWISE PERFORM ALL ACTS NECESSARY TO CARRY OUT THE INTENT OF THIS RESOLUTION; TO PROVIDE AN EFFECTIVE DATE OF THIS RESOLUTION; AND FOR OTHER PURPOSES.

WHEREAS, the duly elected Tax Commissioner of Clayton County, Georgia ("Tax Commissioner" and "County", respectively) is empowered by the Constitution and Laws of the State of Georgia to collect certain taxes, license fees, and all applicable fees; and

WHEREAS, O.C.G.A. § 48-5-146 is authorized to collect taxes and has the authority to contract with the County for the collection of taxes within the City's jurisdictional boundaries; and

WHEREAS, the County Board of Commissioners desires to authorize the duly elected Tax Commissioner, Hon. Terry L. Baskin, to accept checks, money orders, certified funds, credit/debit card payments (including Visa, Mastercard, Discover, and American Express), automated clearing house ("ACH") payments, and wire transfers (with payments to include interest and penalties) as methods of payment(s) for all taxes, fees, and licenses due the Tax Collector's respective office; and

WHEREAS, the Board of Commissioners deems it in the best interest of the County, and the County will best be served by the Tax Commissioner to accept such payment methods for the stated purposes.

NOW THEREFORE, BE IT RESOLVED BY THE BOARD OF COMMISSIONERS
OF CLAYTON COUNTY, GEORGIA AND IT IS HEREBY RESOLVED

Section 1. The Board of Commissioners hereby authorizes the Clayton County Tax Commissioner, Hon. Terry L. Baskin ("Tax Commissioner"), to accept checks, money orders, certified funds, credit/debit card payments (including Visa, Mastercard, Discover, and American Express), automated clearing house ("ACH") payments, and wire transfers (with payments to include interest and penalties) for all taxes, fees, and licenses due the Tax Commissioner's respective office. The Board of Commissioners hereby further authorizes the Chairman or his designee to execute any documents and otherwise perform all acts necessary to accomplish the intent of this Resolution.

Section 2. This Resolution shall be immediately effective upon approval by the Board of Commissioners.


